


# Highway User Revenue Fund Executive Summary


The State of Arizona taxes motor fuels and collects fees relating to the registration and operation of motor vehicles, including gasoline and use fuel taxes, motor carrier fees, motor vehicle registration fees, vehicle license taxes (VLT), and other miscellaneous fees. Revenues are deposited in the Arizona Highway User Revenue Fund (HURF) and are then distributed to the cities, towns and counties and to the State Highway Fund. These taxes and fees are a major source of revenue to the state for highway construction, improvements and other related expenditures.

FY 2003 HURF collections posted a positive gain and met expectations even though the state and national economies were sluggish. HURF collections totaled \$1,111.3 million, an increase of 3.2 percent above FY 2002 and 0.3 percent above the estimate. Except for the "other fees" revenue category, all major revenue categories posted gains over FY 2002 revenue levels. The major contributors to the growth in FY 2003 HURF revenues were the gas tax, VLT, use fuel tax, and commercial registration fees revenue categories.



# **Revenue Trend Analysis**





The annual HURF revenue trend continues to be positive. Over the last ten years, HURF collections have posted year-over-year growth in every year except FY 1998. In spite of an estimated \$7.3 million VLT reduction and registration fees refunds, HURF revenues for FY 2003 grew at 3.2 percent. The reductions were a result of legislation and will be discussed later in the report.

FY 2003 HURF revenue growth was strong for the first half of the year but slowed during the second half of the year. The fluctuation in December and January collections was due to a fuel supplier making a December 2002 payment in January 2003. Overall, FY 2003 HURF revenues came in as expected at 0.3 percent above estimate.


# **Performance By Category**


### Gas Tax:

FY 2003 gas tax collections totaled \$446.9 million, an increase of 2.8 percent above FY 2002 but 0.2 percent below the estimate. Being the largest component of HURF revenues, it contributed 40.2 percent to the total HURF collections. The gas tax growth rate slowed from 3.9 percent in FY 2002 to 2.8 percent in FY 2003. A slower rate of growth in Arizona's population and the sluggish economy impacted the gas tax consumption growth in FY 2003.


The Arizona Blue Chip economists expect the Arizona's economy to improve in CY 2003 and CY 2004. The June 2003 Arizona Blue Chip Forecast reports the wage and salary employment growth rate decreased to 0.0 percent in CY 2002 from 1.0 percent in CY 2001. However, in CY 2003 and CY 2004 the consensus panel estimates are for 2.2 and 3.4 percent growth, respectively.

Also, the June 2003 Arizona Blue Chip reports the growth rate for Arizona personal income was 4.0 percent in CY 2002 compared to 4.8 percent in CY 2001. The estimates for Arizona personal income growth for CY 2003 and CY 2004 are 5.5 and 6.3 percent, respectively.








### **USE FUEL TAX:**

In FY 2003, use fuel tax collections totaled \$166.7 million, an increase of 3.2 percent from FY 2002 and 0.2 percent above the estimate. Even with the sluggish economy and higher fuel costs, use fuel tax collections posted modest growth in FY 2003. The trucking industry continues to achieve a higher level of market share for goods movement than does the rail industry leading to continued growth in the use fuel tax collections.

According to the Arizona Blue Chip economists, business activities in Arizona are expected to grow in CY 2003 and CY 2004. A good indicator for business activities is the gross domestic product (GDP). The June 2003 issue of the Arizona Blue Chip Forecast reports the U. S. GDP for CY 2002 grew by 1.1 percent compared to 2.3 percent in CY 2001. For CY 2003 and CY 2004, the Arizona Blue Chip consensus panel estimates that the U.S. real GDP will grow at 1.8 and 2.1 percent, respectively.

### **GASOLINE TAX RATE:**

The gasoline tax rate chart on the left shows the state gasoline gas tax of \$0.18 per gallon. The last gasoline tax rate increase was \$0.01 in FY 91.


### **USE FUEL TAX RATE**


Presently, the state use fuel tax rate is \$0.26. The large increase in FY 1999 includes a \$0.09 per gallon tax increase imposed on use fuel consumed by "use class" vehicles per Laws 1997, Chapter 8. This increase replaced the \$0.08 per gallon surcharge on use fuel from January 1, 1994 through September 30, 1997, which is not reflected in this chart. As of July 1, 2000, the use fuel tax rate was reduced from \$0.27 to \$0.26 per gallon as part of the 1997 legislation. The use fuel tax rate chart shows the use fuel tax rate per gallon at the beginning of each fiscal year.

### **MOTOR CARRIER FEE:**

For FY 2003, motor carrier fee revenues totaled \$32.9 million, an increase of 12.0 percent from FY 2002 and 3.3 percent above the estimate. The large increase in motor carrier collections was due to a lower base year being used for comparison. In FY 2002, there was a one-time weight distance fee refund of \$3 million that significantly lowered motor carrier revenues. By adding back the motor carrier refunds in FY 2002, actual growth in FY 2003 was only 1.2 percent.





### **VEHICLE LICENSE TAX:**

Vehicle license tax (VLT) revenues in FY 2003 totaled \$282.0 million, an increase of 4.2 percent over FY 2002 and 0.3 percent above the estimate. The rate of growth in VLT revenues slowed from 7.6 percent in FY 2002 to 4.2 percent in FY 2003. This lower VLT growth in FY 2003 was mainly due to an estimated \$5.0 million reduction from the registration plate and fee to owner per Laws 2000, Chapter 198 and the \$1.9 million in refunds for older commercial trailers that were permanently registered in FY 2002 per Laws 2002, Chapter 221.


### **REGISTRATION:**


Registration collections in FY 2003 totaled \$141.3 million, an increase of 2.3 percent above FY 2002 and 2.5 percent over the estimate. This increase in registration revenues was due to the increase in apportioned fees and registration permits and penalties collections. However, this increase was offset by a decrease in county registration collections and a \$0.4 million refund of partial registration fees to older permanent commercial trailers per Laws 2002, Chapter 221. The increase in apportioned fee revenues was due mainly to the timing of other states remitting monies to Arizona for the previous fiscal year.

In the June 2003 issue of the Arizona Blue Chip Forecast, Arizona's population grew to 5.5 million in CY 2002, an increase of 2.8 percent from CY 2001. CY 2002 population growth was the slowest over the CY 1994 to 2002 period. It is projected that the Arizona's population growth will continue to slow to 2.6 percent for both CY 2003 and 2004, which could result in continued low growth rates in county registration revenues.


### **OTHER FEES:**

In FY 2003, the "other fees" revenues totaled \$41.5 million, a decrease of 0.9 percent below the FY 2002 and 2.6 percent below the estimate. The other fees revenue growth was lower in FY 2003 due to increases in credit card reimbursement payments and Motor Vehicle Division third party contractors payments along with decreases in use fuel permits and penalties and lower investment interest income.










## **Revenue Composition Comparison**






HURF revenue growth would have been greater if not for registration plate and fees to owner VLT loss and the refunds for older commercial trailers that were permanently registered in FY 2002 as noted in the VLT and Registration sections.








# ARIZONA HIGHWAY USER REVENUE FUND SOURCES AND DISTRIBUTION OF FUNDS **FY 2003**



### REVENUE CATEGORY DEFINITIONS

GASOLINE TAX

A per-gallon tax imposed on gasoline used by vehicles on Arizona highways; presently this tax is \$0.18 per gallon.

USE FUEL TAX

Includes all gases and liquids used to propel motor vehicles on the highways in this state except for motor fuel (gasoline). Use fuel consists primarily of diesel fuel. Diesel fuel tax was \$0.27 per gallon, but dropped to \$0.26 per gallon on July 1, 2000 for "use class" vehicles. "Non-use class" vehicles continue to pay \$0.18 per gallon. Jet fuel is exempt from fuel and use fuel taxes.

**MOTOR CARRIER** 

FEE

A fee imposed on certain commercial carriers based on vehicle weight. Category also includes: Motor Carrier License Tax, Motor Carrier Tax Penalties, late fees and interest, and Motor Carrier Permits Tax, and application fees.

**VEHICLE** 

LICENSE TAX

An annual license tax imposed on registered vehicles in lieu of property taxes.

REGISTRATION FEES

Is made up of three distinct components:

County Registration - non-commercial and commercial vehicle registration, and commercial weight fees.

**Apportioned Registration** - commercial registration fees allocated according to miles traveled in Arizona.

Miscellaneous Registration - Non-resident Permits, Unassigned Registration, Prorate Stickers, and Registration Penalties.

OTHER FEES

Includes Title Fees, Operator Licenses, Oversize/Overweight Permits and Highway Fines, Inquiry Fees, Use Fuel Permits and Fuel Tax Penalties, Investment Interest, Special Plates, and Other Miscellaneous Fees, less Credit Card Fees.
