He raised a company of volunteers in Yuba and Nevada Counties and was mustered in on November 25, 1864 at the Precidio of San Francisco, to serve 3 years as Captain, Company I, 7th California Infantry; stationed at the Precidio until May, 1865, when he went with the Company via Fort Mohave and arrived at Fort Whipple, A.T., late in July; was stationed there until February, 1866, when he returned to California with the Company and was honorably discharged at San Francisco, March 31, 1866.

He returned to Arizona and was Coroner of Yavapai County in 1867; listed U. S. Census, 1870, at Prescott, A. T., age 42, eccupation-Doctor, property valued at \$2,000; his advertisement in the Prescott Arizona Miner of January 27, 1872 reads:
