New Section.

Sec. That the Secretary of the Interior may execute leases to parcels of ground not exceeding 100 acres in extent in any one place, for not to exceed 50 years, to any person who is the head of a family, or who has arrived at the age of 21 years, and is a citizen of the United States, or who has filed his declaration to become such, as required by the naturalization laws, where such lands are within the exterior limits of the Grand Canyon National Park and are either isolated or partly or wholly surrounded by lands owned in fee simple; Provided, that in such leases preference shall be given to the owner of such adjacent lands partly or wholly surrounding the lands belonging to the United States, and provided further, that such parcels of ground shall be used only for residence and not commercial purposes;

New section

Sec. That the Secretary of the Interior, for the purpose of consolidating the lands within the Grand Canyon National Park, be, and he hereby is, authorized and empowered to exchange lands belonging to the United States which are part of the Grand Canyon National Park, for privately owned lands lying within or without the exterior limits of the said National Park: Provided that such lands of the United States, lying within the exterior limits of the said National Park are partly or wholly isolated, or partly or wholly surrounded by the lands privately owned and sought or offered in exchange; And Provided further that the lands so exchanged shall be substantially equal in area and in value.

Provided, that where such lands within the Grand Canyon National Park belonging to the United States have not been surveyed, they shall be surveyed by the Commissioner of the General Land Office at the expense of the private owner, and that all minerals and mineral deposits within any such land are reserved to the United States, together with the right to prospect for, mine and remove the same, and upon the further condition that if merchantable timber exists in commercial quantities upon any lands so exchanged, it shall not be cut and ~~there~~^{it} shall be reserved to the United States.

Provided, that where the Secretary of the Interior and the owner of such private lands may not agree upon an exchange, the Secretary of the Interior is hereby authorized and empowered to sell such isolated lands belonging to the United States, or lands partly or wholly surrounded by the lands so privately owned

Proposed amendment to H. R. 20447.

Change Section 4, page 7, to read as follows, (new matter underlined).

Sec; 4. That nothing herein contained shall affect any valid existing claim, location, entry, or land privately owned, under the land laws of the United States, whether for homestead, mineral, right of way, or any other purpose whatsoever, or any leasehold, or shall affect the rights of any such claimant, locator, entryman, lessor or owner, to the full use and enjoyment of his land.

upon payment to the United States of the same amount per acre as paid by the owner of such adjacent private lands for the lands partly or wholly surrounding the lands owned by the United States, such amount to be not less than \$1.25 per acre: And provided further, that upon the consummation of such exchange or sale, the lands deeded to the United States thereunder shall become a part of the Grand Canyon National Park.
