## WHO KILLED HARVEY MILK?

Out of Eleven Supervisors,  
Why Was Harvey Milk  
Singled Out?

"Should we continue to be maligned and shamed throughout the nation? I say no.

"...I am not going to be forced out of San Francisco by splinter groups of radicals, social deviates, incorrigibles...Believe me, there are tens of thousands who are just as determined to legally fight to protect our constructive values.

"By choosing to run for supervisor of district 8, I have committed myself to the confrontation which can no longer be avoided by those who care."

"Our laws were never meant to protect the abnormals and were made for the majority."

—Anita Bryant.

We are told that Dan White is a "normal" man who cracked under pressure. There is much truth to this, and vengeance against one individual will not solve the problem.

His basic mentality is a symptom of a greater evil. An evil that has produced everything from carloads of straight punks who attack individuals in our community, to the Inquisition and the Nazi holocaust.

A great many of the gay people here are refugees. Refugees from police brutality, having our jobs taken from us, from family rejection, from being outcast and humiliated.

## Screams of shock shatter wordless waiting at City Hall

The reporters had headed over to City Hall for what was likely to be a front page story: Mayor George Moscone had decided not to reappoint Dan White to his old post as supervisor but to give the job to a newcomer.

The mayor's office had handed out press releases in advance to The Examiner and other news outlets with early deadlines.

Examiner reporter Alan Cline

had completed dictating the announcement — that Don Horanzy would become the new supervisor — when he heard these words:

"The mayor's been shot."

The word hadn't come instantaneously.

White had entered the mayor's private room. The two had talked. Something that sounded like shots or perhaps a car backfiring had been heard by the mayor's secretaries on the other side of the wall.

The secretaries had checked out the window and noticed nothing amiss.

It wasn't until the man waiting to see the mayor next, budget analyst Rudy Nothenberg, opened the mayor's door that the body of George Moscone was found shot in the head and arm.

Moments later, reporters received a call in the City Hall press room. "The mayor's been shot," they were told.

The five or so reporters in the room ran to the mayor's office, but by then that part of the building had been sealed off by police of every description.

Joyce Bonifield, aide to Supervisor Carol Ruth Silver, recalled the scene:

"About ten minutes to 11, I was going downstairs to the assessor's office when I saw two policemen running upstairs. One had a rifle or a shotgun and hollered to the other, 'It's the mayor's office.' I went right back to our office and said, 'God, this is really weird place.'"

"Then I went outside with Barbara Dawson (another aide), and we saw Peter (Nardozza, aide to Supervisor Feinstein) outside the supervisors' office."

"He shouted, 'Something's happened. Harvey's been shot.'"

## Aide: White 'a wild man'

Mayor George Moscone and Supervisor Harvey Milk were shot and killed today at City Hall and troubled ex-Supervisor Dan White turned himself in to police shortly afterward.

The shootings occurred about 11 this morning as Moscone was preparing to hold a press conference naming Don Horanzy, a real estate loan officer, to replace White on the Board of Supervisors.

Moscone was shot in his office. Milk was shot in White's office, where White had invited his political opponent to join.

White had wanted to be reappointed to the Board of Supervisors, but Moscone had decided not to do so and Milk was the leader of the opposition to White.

The announcement that Moscone and Milk were dead was made by a shaken and tearful supervisors President Dianne Feinstein. She now becomes acting mayor.

Police said three bullets were found in body.

About a half-hour after the shootings, White turned himself in to police at Northern Station and was taken to the Hall of Justice.

After a 90-minute interrogation at the Hall of Justice, he was taken to the sixth-floor city prison by six policemen. Wearing a tan three-piece suit, White looked grim and nervous. He bit his lips and shook his head occasionally.

Witnesses said White was acting "like a madman" before he met with Milk.

At about 11:20 a.m., Feinstein walked out of the mayor's office with Police Chief Charles Gann and confirmed that Moscone and Milk had been shot to death.

Feinstein was shaking so badly that Chief Gann had to support her. The crowd around them gasped and shouted when the news was announced.

Feinstein later issued a statement that began: "Today San Francisco has experienced a double tragedy of immense proportions."

Flanked by other supervisors and city officials, Feinstein said she had heard three shots coming from White's office, where Milk was killed.

She said she expects to be a witness at the trial, that she has made a full statement to Chief Gann and district attorney's investigators, and has been instructed to say no more.

The mayor's body was taken out of his office on a gurney. A priest had gone through a back door to the mayor's office at 11:40 a.m. When he came out five minutes later, he said Moscone wasn't there.

Just after noon, Milk's body was removed from the supervisors' suite of offices on a stretcher covered with

## Feinstein taken over as mayor

Dianne Feinstein, as president of the Board of Supervisors, immediately assumed the duties of mayor until the board itself elects a successor.

According to section 3.100 of the Charter, the supervisors (as a body) have the obligation of choosing someone to fill the unexpired portion of Mayor Moscone's term, which would have ended at the close of 1980. In other words, there will be no election to replace his successor until next year.

Until the supervisors have met to decide the matter, however, the charter provides that the president of the Board of Supervisors assume the office. Next in the line of succession is the chairman of the finance committee (Gordon Koppi) and the senior member of the Board of Peleoli.

If the supervisors cannot agree on a successor, the president of the board will remain as mayor, according to Mel Wax, Moscone's press secretary.

Feinstein will exercise two functions, according to City Attorney George Agnost, that of acting mayor as well as president of the board.

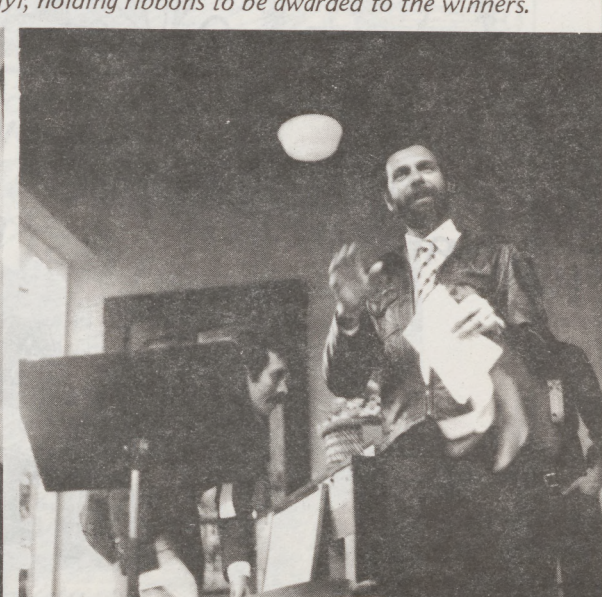

Champagne among the troupe who gave and gave and gave to the wall-to-wall audience who crammed themselves into the Casa for a really fine evening.

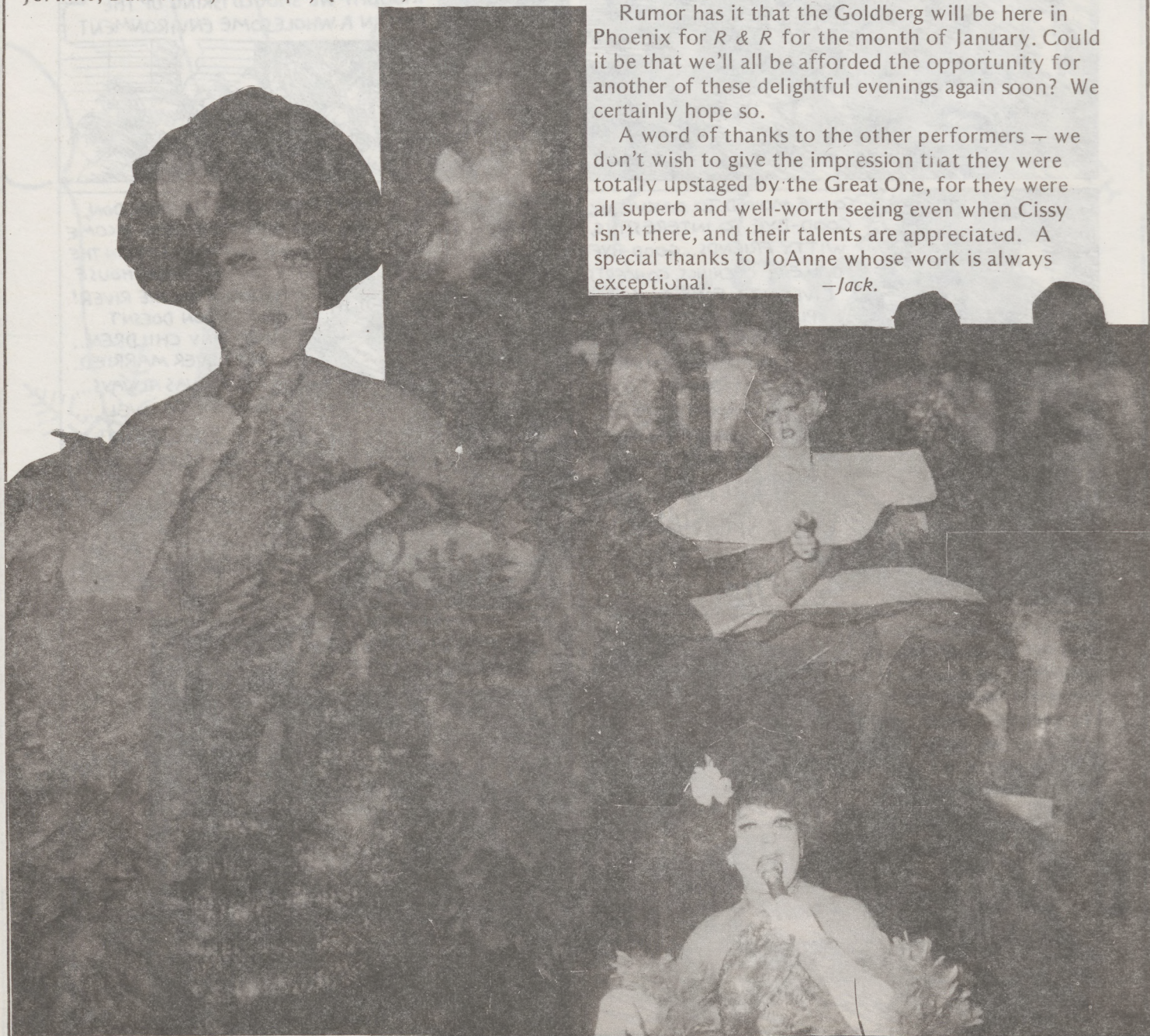

## 50 protest appearance by singer Anita Bryant

With organizers calling it the first gay rights demonstration in Louisville, about 50 people marched in a cold rain last night to protest Anita Bryant's appearance at a meeting of the Kentucky Farm Bureau.

Holding signs such as "Now is the time for gay rights in Louisville," the protesters marched in front of the Executive West Motor Hotel, where Miss Bryant was to sing.

The march was organized by the National Organization for Women and the Metropolitan Community Church. It began about 5:45 p.m. and ended about 45 minutes later.

Protesters could barely be seen in the darkness by passing motorists as they marched on the northeast corner of the Executive West grounds, several hundred feet from the main entrance. By the end of the march, many were soaked and their waterlogged signs were hanging limply in their hands.

"We're here because of Anita Bryant and those like her who spread myths about gays and lesbians," said Sherry Turner of NOW.

Miss Bryant has been outspoken in

her stands against gay rights and other equal rights movements.

"This is our way of educating the public," she said. Ms. Turner said she believed the march was the first gay rights demonstration held in Louisville.

"It's high time we did organize," she said. Gays in Louisville face discrimination in housing and employment, she added.

The Rev. Sandy Taylor, of the Metropolitan Community Church, said she thinks members of the gay community in Louisville have been afraid to speak out because of the effects that may have on their families and because of a fear of jeopardizing their jobs.

"People have been waiting for some leadership and help in forming groups," said Ms. Taylor. She is a minister at the Metropolitan Community Church, which has a ministry for gays and wants to organize groups in the community.

While the majority of marchers were gay, she said, "I believe many are professional people, heterosexuals in support of gay rights and the church."

There were no incidents during the march. The hotel had one security guard stationed at a covered pavilion next to the march site.

# An interview with Harvey Milk

**Q. People have often contended that the gay rights movement seems to grant homosexuals a special, privileged status in society, and that to support gay rights is to condone homosexuality. How do you answer that?**

**A.** That's wrong. That's their lack of reading below the headlines. All gays want is what everybody else has. No more, but no less. We don't want any favors, and we don't want any more than anyone else is getting as far as protection under the law and our right to participate in all aspects of society. We just want equal protection. People are equating gay rights and affirmative action programs. Nobody that I know of in the gay community is asking for affirmative action for homosexuals. I think that's how people misconstrue what the gay rights movement is all about. What we do want is equality.

Supporting gay rights does not mean supporting homosexuality, just as supporting black civil rights does not mean you have to like or love black people. But you respect their right under our democratic system and under the Constitution to have equality. You don't even have to accept the idea of homosexuality; what you are accepting is the right of all people to exist. You are just reaffirming what the Constitution says, and what is chiseled into the Statue of Liberty.

**Q. Some gays here think the gay community in San Francisco is so well accepted that an Anita Bryant-style campaign couldn't succeed. Are they right?**

**A.** Unfortunately, I think they're wrong. It's true that we've done our homework, but we've taken the "getting to know you, getting to know all about you" approach. That's vital and important, but we have never really addressed the myths that Anita Bryant used in her campaign. The Anita Bryants will talk about child molestation and role models, and unless we address that we're in trouble.

The survey in Miami after the vote said that most people voting against us thought we were child molesters. In California 95 percent of child molestation is heterosexual. Unless we talk about that we'll be labeled child molesters. The same thing about the Bible — unless we address the issues that are brought up about the Bible, we're in trouble. We must address the real issues that will be thrown at us — the smear campaigns, the myths, the lies, the distortions — and expose them.

**Q. What do you say to gays who feel too much money, time and energy are being devoted to the political process, rather than educating the public about homosexuality?**

**A.** You don't educate people overnight. You've had centuries of discrimination against blacks, and there's still rampant prejudice against them. Against gays it's gone back thousands of years, and you can't eradicate that in one generation.

We wouldn't have to be fighting Briggs so hard and spending all this money to educate when for a much smaller amount of money we could probably have elected some gay people to Sacramento. They would have been working and showing what gays are like, just as I'm showing people here that we're involved with taxes and dogs — and Muni and everything else. So that people say, "Hey, you know it doesn't matter if a person is green with six heads. That person is good — good on human issues, good on taxes, good on environment."

Every poll says that people who are on the gay side are people who know a gay person well. How do you get to know a gay person well? They have to be out of the closet. And who is more out of the closet and more exposed than a gay official?

The reason so much has been accomplished in the black movement in a short period of time is that blacks have gotten into elected offices and many have shown great leadership qualities. That has done more to educate people than education has. My involvement with issues in this city — and I'm not saying if you agree or disagree with my stand — has done more to educate the public about gays than standing outside with pamphlets, writing literature and making TV ads. And why should there only be one elected gay official in this city? So many of these people who are against putting money into politics feel there can only be one gay leader, and if it can't be them they're against politics. I think history will show that's the wrong approach.

**Q. How would you like to see gay people address those issues?**

**A.** What they have to do is to come out to their friends, their neighbors, their relatives, the people where they work, and dispel that myth. So you're telling the gay people what they must do, and you're educating everybody about what the real facts are. Unless you're willing to get down to that nitty-gritty and talk about those issues, then the Anita Bryant campaign will work.

**Q. There seem to be a great number of factions in the gay community, and often they appear to be fighting among themselves more than working toward a common goal.**

**A.** That's true in any community. You name me the black leader who controls the black community in this city. There isn't one. There are 40 or 50 black leaders. The same is true of the Chicano community. There's not one group that's ever had it all together, and gays are even more divided because we cover all economic strata and racial and ethnic groups. Blacks are all black. But gays are black, Asian, Chicano, white, men, wealthy, poor and so forth. And to expect a very wealthy, white, well-educated gay man to relate completely to a very poor, black lesbian — as an example — is ludicrous. A lot of us are doing our best to bring them together. But it's difficult when you have gays who are staunch socialists and gays who are reactionaries. To sit there and expect that we will all unite under one common banner is crazy.

**Q. One of the divisions in the gay movement is between lesbians and gay men. Do you see the two groups working together toward common goals?**

**A.** It's happening right now. I'm working with a group called A United Fund to Defeat the Briggs Initiative. Most of the lesbians in the group are strong separatists, yet we are working together. The group has been in existence for just a short while and it seems to be working. What's important is what happens to the coalition after the election in November. I think many lesbian separatists and gay male separatists will be very surprised. If you look at the letterhead of the group, it says in a bold headline, "A United Fund," and underneath in smaller print it says, "To Defeat the Briggs Initiative." You can be sure if we defeat the Briggs initiative, the big headline will remain "A United Fund," but the smaller line may change to "To Support the ERA" or

"Bring Back Abortion." We have structured it so that the concept of working together will continue to other issues.

**Q. Many gay people think it's a mistake to link the gay movement with other questions, such as the Bakke decision or abortion, for example. Where do you stand?**

**A.** I don't think it's wise to tie other issues into the Briggs initiative by itself. But I think it's imperative that those people who have been disenfranchised work together on all issues. We must work together on Bakke, abortion, the ERA, the American Indian issue, Latino issues, etc. So the blacks, for example, must come to the aid of the gays on the Briggs initiative — as anti-gay as some black people are. They must come together with us on this issue, just as we must come together with them on their issues. That doesn't necessarily mean linking the campaign literature, because that's not the way it works politically. But we must join forces.

If you look at who's against gays, who's against blacks, who's against women, and on and on, you find that it's the same people — the Richard Nixons of this country. And if the blacks and browns and Asians and women and gays are all going to fight each other for the same crumb, they're all going to be disenfranchised.

I think the gay community has to stop voting its pocketbook. There were gays who voted for Jarvis-Gann. They voted for their economic interest, despite what a racist bill it was. I think it's time to educate the gay community that it's no good having a lot of money if you're in jail because you're gay. So what some of us are trying to do is to put together a coalition of all the traditional minorities — people who have gotten nothing over the years — so we can stop fighting among ourselves and work together.

**Q. Graffiti urging "Gay Riots Now" have been appearing on some walls in The City. Do you think gays would — or should — turn to violence to protect what they see as their basic human rights?**

**A.** I don't think anybody should turn to violence. I am non-violent. I believe in non-violence. But I think I would be remiss in my duties as public leader not to discuss the definite possibility for violence, given the fact that a certain percentage of the population is violent by nature. Let's say for argument's sake that one percent of all people are violent by nature. Then you're talking about 100,000 to 150,000 gay people nationwide who are violent people. If they watch their rights being chipped away, that is justification for them to come out with their violence. In the city of San Francisco, you're talking about 500 to 1,000 gay people who are violent by nature, and will react in the same way.

Gay people are angry ever since Dade county, and they're getting more and more angry. After the vote in Eugene, Ore., there were a thousand people marching in the streets of San Francisco, and when they walked past City Hall most of them were shouting, "Civil Rights or Civil War!" On the other side of the coin, there is violence being committed against gay people every day. If Briggs wins, there will be a green light for more violence against gay people. Look what happened in New York City recently, when young gangs took baseball bats and went through the city and Central Park beating up gay people or anyone they thought was gay.

Do you think gay people are going to go with

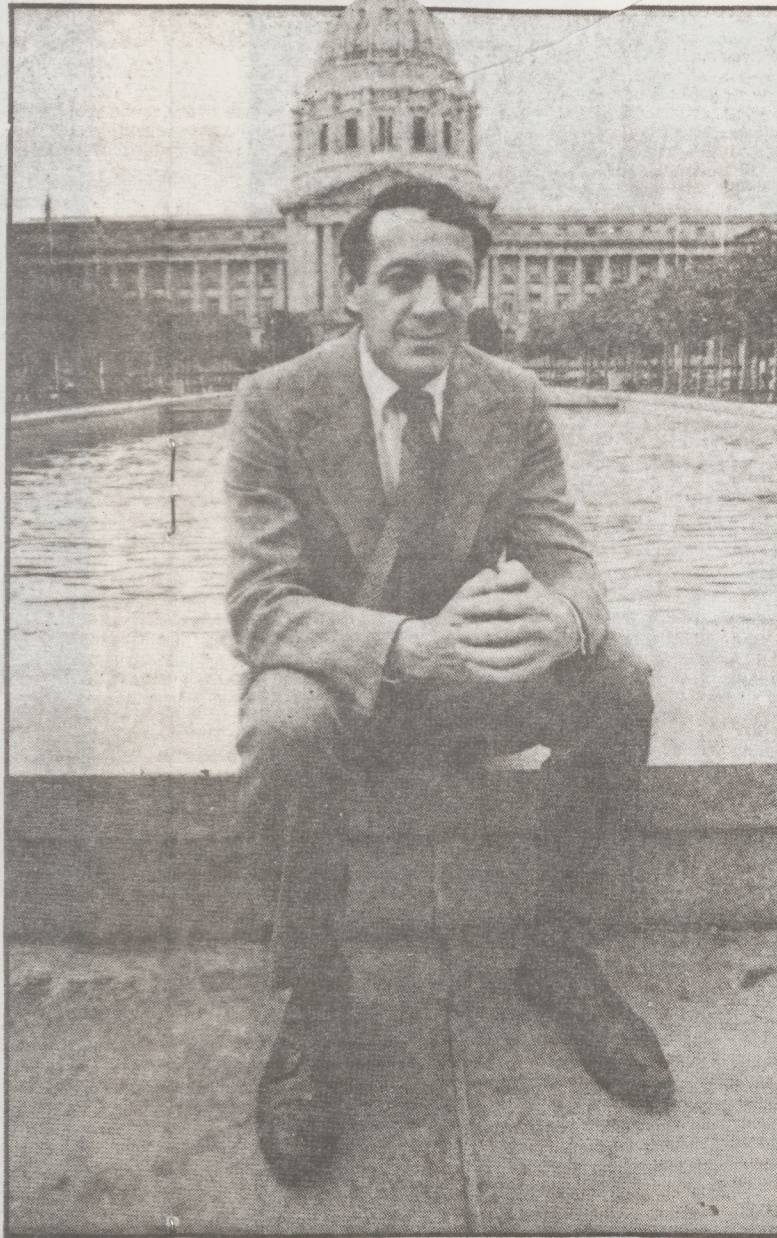
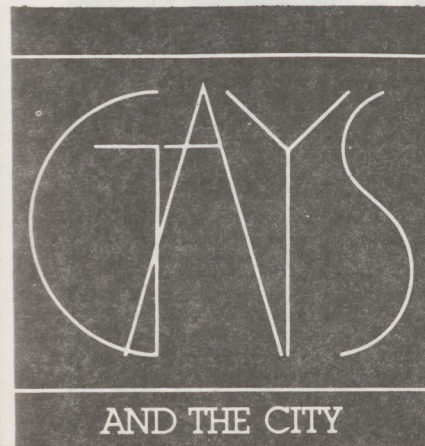

their heads bowed into the gas chambers? I mean, I'll go kicking and screaming before I go with my head bowed. I've read history; 300,000 gays went into the gas chambers in Germany, and then six million Jews. I don't think the Jews are going to go quietly the next time, so why should gay people?

**Q. Even if it doesn't reach a point where gays turn to violence, some have argued that civil disobedience should become a tactic of the gay movement.**

**A.** Rights are not won on paper; they are won only by those who make their voices heard. They are won by activists and militants. Silence never won rights. They are not handed down from above. Rather, they are forced by pressures from below.

Civil disobedience won blacks the attention, and black violence frightened a lot of people. There are gay people studying history, and they are learning that lesson. They're realizing that Jimmy Carter is more concerned with the human rights of people in Russia than he is about gay people in the United States. A lot of them are apparently deciding that civil disobedience is the route. History is going to show that gay people are eventually going to win their rights, no matter what. So I would tell Jimmy Carter that he has the chance to turn the pages of history faster and prevent violence and civil disobedience from happening.

**Q. Gays in San Francisco are covered by a number of city antidiscrimination ordinances. How well do you think these ordinances are actually being enforced? Are gays really protected against discrimination?**

**A.** I think the main advantage of the gay rights ordinance in this city is not to force people to hire gays, but rather to protect those gays who are already employed from being fired. Probably the most sensitive area is the medical profession. There are a lot of gay doctors and psychiatrists who work for major institutions; in the past they would have been fired if it became known that they were gay. So they had to be closeted. Now, partially because of the Briggs situation, a lot of these gay professionals are coming out, because they know they are protected. If they've been working for an institution for a number of years — getting promotions and good evaluations — and now they are fired after they come out, the reason is pretty obvious. They're protected under the anti-discrimination ordinance.

Let's face it — it's not going to be perfect. There are blacks who are discriminated against. There are Latinos and women who are discriminated against, and there are laws on the books against all of that. To think that a gay rights law is going to cure everything

all at once is naive. But I think it's vital that the professional class be protected, because when they come out, they break down the commonly held stereotypes about gay people.

**Q. Was it a mistake to pass gay rights ordinances around the country in the first place?**

**A.** The Constitution of the United States was not meant for the majority; it was meant to protect minorities. I'm sure if we put it to a vote, we could outlaw black teachers in some places, and Jewish teachers in others, and Holy Rollers in others. It's easy to legislate against a minority. That's what the Constitution was set up to prevent.

But even if gays lose in these initiatives, people are still being educated. Because of Dade County, the entire nation was educated about homosexuality to a greater extent than ever before. In the weeks before and after Dade County, more was written about homosexuality than during the total history of mankind. More people said "damn queers" than ever before, and for many it was the first time they'd used the word "queer." That's the beginning of a dialogue. Maybe the result was wrong, but it was the beginning of an education. The first step is always hostility, and after the hostility you can sit down and talk about it.

That's why after Dade County the campaign in Wichita was slightly different. It was different in St. Paul and Eugene. Each time more myths were shattered, and they had to reach further and further for their arguments. Maybe we'll lose 50 races, but by the end there will be no more myths. No one will be able to claim we're child molesters.

**Q. In light of the political defeats gays have suffered around the country, where do you see the gay rights movement going now?**

**A.** The call for a march on Washington is taking place, so the next major step will be a mass meeting in Washington, we hope around the 4th of July of the coming year. This will not only be a mass gathering, but will also include seminars, workshops and the setting up of a national political network.

On the local level, you're finding that the battle against Briggs in this city is putting a lot of gay people into the political process — people who have never been in it before. There will be a carry-over that will affect all political races in The City. Once people become politicized many of them stay politicized. That means there will be more gay people involved — not only in running for office, but also involved in initiative campaigns, proposition campaigns and working for candidates. I guess the best way of putting it is, you're going to see the maturing of the gay political consciousness because of the Briggs initiative.

In order to share our insight into this rare man, we are printing an extensive interview conducted with Milk, by Lenny Giteck, shortly before last month's elections. The interview was scheduled for publication next Monday as part of our continuing series on The City's gays. It is more appropriate today.

Milk, of course, did not speak for all of San Francisco's gays. He was, however, a symbol of the determination of gays to take an active role in all areas of The City's life.

In his tiny office at City Hall Milk discussed his hopes and dreams for all of San Francisco and his special concerns for his followers — all of whom he urged over and over again to say "I'm gay."

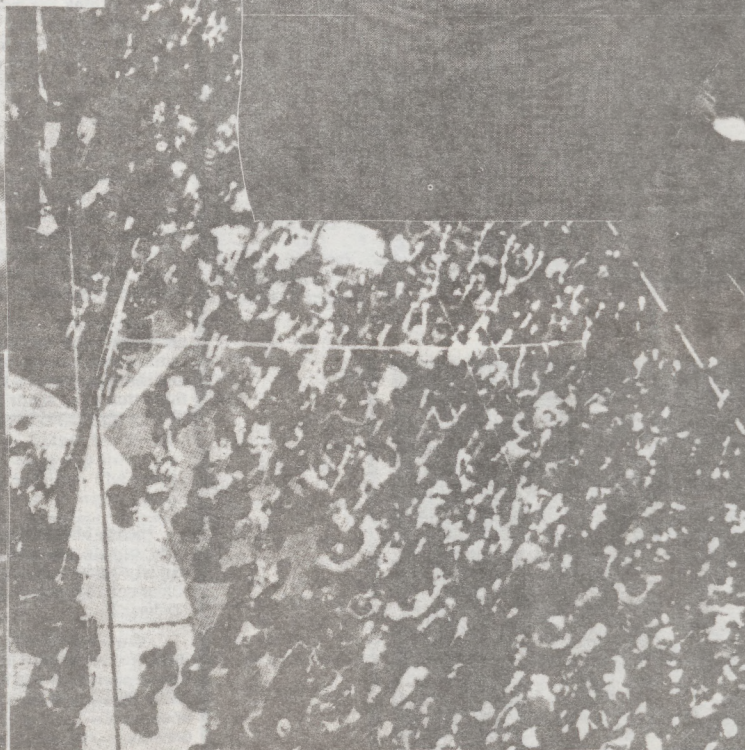

Senator Briggs was stopped short by the voters of doing any "cashing-in" with his shabby pretense of morality. Our struggle is hardly over, though. We must continue our fight for individual rights. 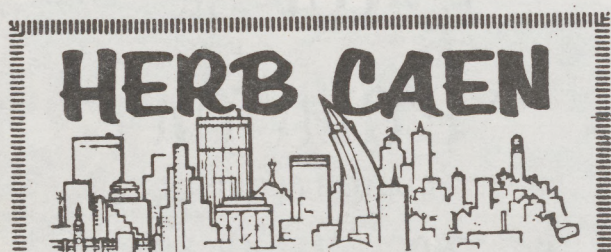

## BLIND! (in one eye)

Darkness shrouding the trees, a dim path through the woods; barely visible, the moon is a tiny slit in the star-filled night sky; crickets chirping loudly in the warm, humid Southern night. But cricket sounds and deep shadows give way as a small frightened boy and his loving grandmother move quickly along the path. Up ahead, soft sounds are growing louder; a great tent looms up before us; shadows of hundreds of human forms are silouetted against the inside of the tent — dancing, moving, the silouettes are cast by many glowing yellow lights.

Suddenly, as if we were being swallowed, we move through the singular opening in the great tent. The silouettes have taken form — growling, clapping, dancing, singing and praying people, and all eyes are cast upon the two people at the front of a huge snaking line of wobbling wheel chairs and crutches. Very old people are being led by younger ones and (as with myself) the very young being held by their parents. Mamma has a tight hold of my trembling hand, my eyes are staring big and blue at the two people at the end of the line — a very old man in a wheelchair just in front of us is speaking to the preacher. It's his turn to be "healed".

Grabbing the old man by his head, the preacher hauls the old man from his chair, and his trembling old body is standing level to the eyes of the preacher.

I tug back, Mamma pulls me forward, the fear in me increases as the preacher screams, "*In the Name of the Lawd Jesus Heeel! HEEEL!!*"

The fear increases, I want to get out of here —

"It won't be long now, it's almost your turn." "But Mamma, I'm so scared!!!" "Now, darlin' it won't hurt a bit, and the preacher will make you see out of both your eyes with the help of God, and it will be wonderful not to be half blind." "OK, Mamma, but I'm plenty scared."

The old man in front of us is on his knees praying and grabbing handfuls of dirt. His eyes are wide, he muffles his screams by stuffing the dirt into his mouth and a strange jabbering and grunting is pouring from his lips. "Speaking in tongues!" the crowd is shouting. The old man with dirt and spit on his face is screaming at the crowd.

"Please Mamma, I'm only seven years old, why am I here? Get me out!!" But she doesn't here — she seems lost among the dancing, singing, clapping, praying which is growing louder each minute. The preacher is barely heard as he keeps shouting, "*In the Name of the Lawd Jesus Christ...HEAL! HEEEL!!*" His sweating face is bulging and red with hysteria at he screams at the old man (who has just ruined his pants) "*Walk! Walk!! I command you to WALK!!!*" The crowd joins, "*Walk!! Walk!!*"

The old figure takes two painful steps and falls from the dirty platform into the arms of the screaming crowd.

"*Thank you, Jesus. Thank you, Jesus!*" yells the preacher, and it is repeated by the crowd. "Sweet Jesus, I can walk!" shrieks the old man as he is swallowed by the undulating figures.

Now the red eyes fall upon me; the crowd drops to a murmur, and I'm so scared. "Please don't touch me." The hand is holding me, his sweating face suddenly staring into my eyes. I'm pulling away in terror — sudden pressure, powerful grip — "GOD HAS GOT ME!!!" White haired old face all dressed in black, she looks like the wife of the devil — old hands, so strong! "Mamma, don't let them do this!! Stop!!" The red eyes are using all the air in the tent, how can the old woman helping him hold me so still? The

yellow lights swim past me (it seems there are many hundreds of them) "Let go of my hair!!!" He twists my neck so violently — Snap!!! For an instant it seems he has killed me, I am being dragged onto the stage, the people are wild — singing, praying, shouting that strange language again. Several pants are ruined, dirt is flying and the heat is awful, I think I'm going to throw up.

"*By the Lawd God and in the Name of Jesus, I command you to be healed. What's the matter with the kid?*" From somewhere my Mamma's voice says, "He's blind in one eye. Help him see, help him to the truth of the power of God. Help him see as well

as you!" She puts money into his hand. He pushes it away, "*Not yet, not yet.*" The pain from my hair is awful again as he yanks my neck, SNAP!!!

"*Half blind,*" he says, "*Son, look at me. Do you believe in the Lawd Jesus Christ?*" Yank — snap — pain. "Answer him!" that old woman jerks my arm, "You must answer him!"

"I don't know. Please let me go, that hurts —" More pulls on the hair. "*HEAL! HEAL!!*" "Please, stop, you're hurting me! Mamma, please!!" The dirt is flying, the lights are swimming again. "*Heal! By the Lawd God Almighty, I command you to be healed! SEE!! SEE!!!*" He is shaking me and violently slaps me across the face. "YES!! YES!!" shouts the crowd. The dirt is getting into my eyes and grit is running off the red face, a tiny child is lying on the ground, the father is covering her with dirt and the mother is removing it, my eyes move. "YES! YES! He can see! Show us you can see!!" The old man from before is lying on a bench waving his clenched fists in the air "SEE!! SEE!!" he shouts. My eyes move. "Mamma! Help me!!" Tears are filling my

eyes, SLAP!! "SEE!!"—Dirt ant tears—"Are you possessed by the Devil, can't you see?!!" "Yes, he can see!!" shouts the crowd, stomping up more dirt. Tears and dirt blinding my good eye "I AM EVIL, I CANNOT SEE AT ALL!! GOD HATES ME, I CAN'T SEE ANYTHING!!"

Sudden extremely loud screaming — SLAP!! — The red eyes, the yellow lights, the grey hair, the wheel chair — a spinning blurr, I can't speak, I can't see — SLAP!! — Pain — "Mamma! Help me!!"

"The Devil is here, the kid is blind!! Woman get thy son out of God's temple, he is EVIL, EVIL, EVIL!!!" "DEVIL, DEVIL" shouts the crowd, "The Devil is here!! Pray him out, pray him out!!" The drug of terror and hysteria grips all inside the tent, the wife of Satan is pulling my arms — down from the stage, the preacher jerks his hands from me like I was on fire, "HELP ME, I CAN'T SEE!!"

The hem of Mamma's dress is wiping my face. "Mamma, what have they done? That feels good, Mamma, I can see," she is wiping the grit and tears away. "Oh, I'm not blind, get me out of here."

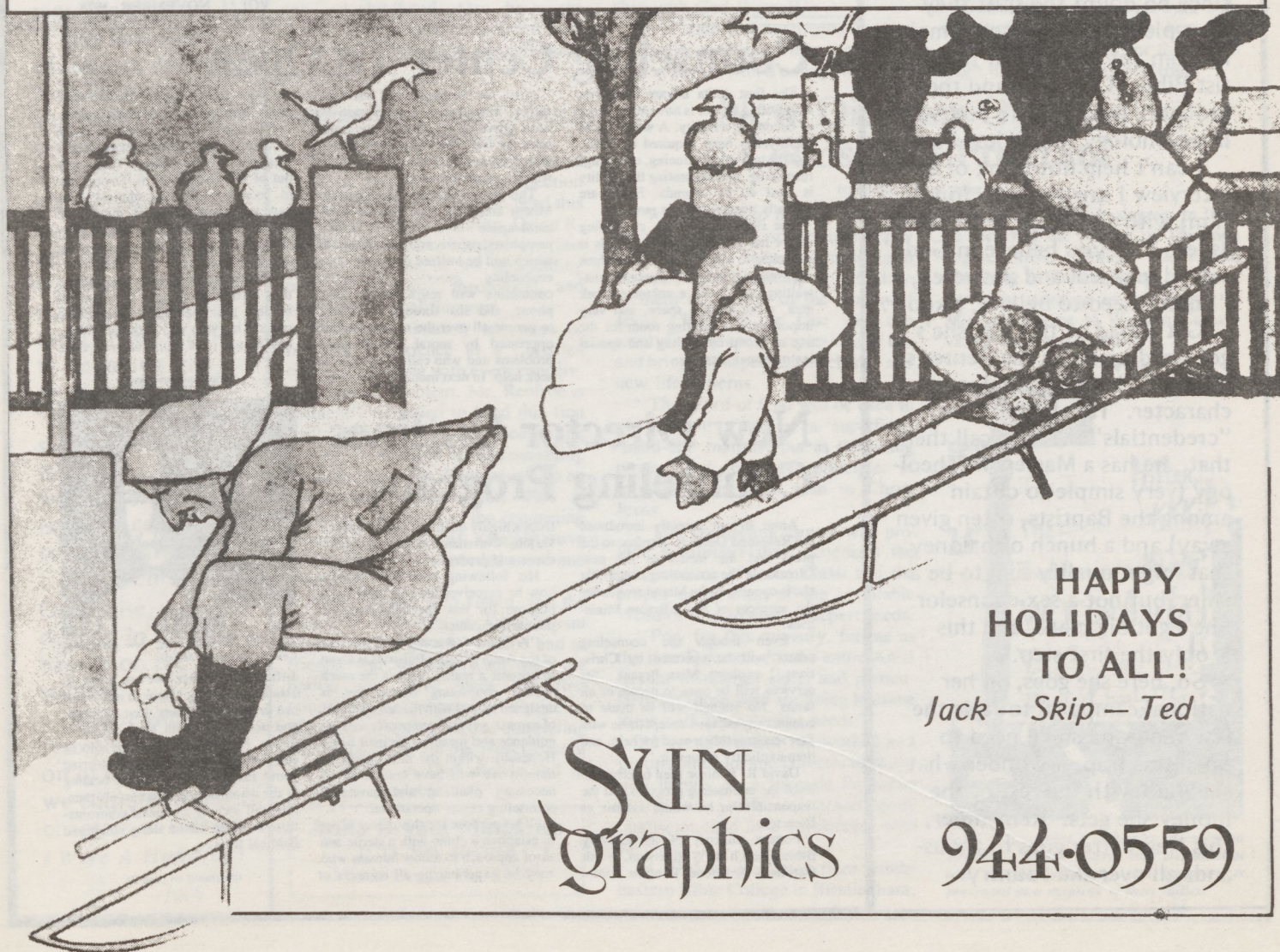
The line moves. A frail, frightened figure somewhat older, but looking so much like me is being pulled onto the stage, four men are holding him — one for each limb — the men are speaking to the preacher; his eyes have grown wider and redder, the old woman is throwing water on the terrified figure.

The preacher grabs the boy by an arm and a leg and shakes him violently, sucking in the last remaining air as he begins to scream, "In the Name of the Lawd Jesus Christ, heal this queer, HEAL!! HEEEL!!!" The crowd roars, "Heal, queer; heal queer!! YES!! YES!! (Slap!) Queer!! (Slap!) HEAL!! (Slap!) HEAL!! HEAL!!"

The frail figure crumples to the floor — the old woman is calling to the "special" people at the sides of the tent. She motions them and they carry the (now fainted) figure away. "The Devil has left him, he is free from sin, he is healed. The QUEER IS HEALED!! THE QUEER DEVIL HAS LEFT HIM!!" the preacher shouts and the crowd again goes wild as the white faced boy is swallowed up in the sea of people. The sobbing father, so relieved, while praising God is placing a twenty dollar bill into the old woman's hands and runs joyfully from the stage. "My son is free from the Devil!!..."

As in a dream I'm walking forward, and as I look over my shoulder the mouth of the tent is growing smaller and smaller, and so are the figures of the devil and his wife bathed in the holy yellow light inside. Now the animal sounds from the tent are giving way to the crickets and the tiny slip of a moon guides our steps through the woods. I clutch Mamma's hand tightly as we silently walk home.

## Counseling Center To Open

The first Anita Bryant Ministries Counseling Center is now on the verge of becoming a reality. A well-located facility has been acquired by lease, and the task of partitioning, carpeting, furnishing, and decorating the facility is next on the agenda. Funds are urgently needed for this purpose.

The floor plan of the counseling center has 1,800 square feet. This is sufficient to provide initially for three counseling rooms plus a receptionist-waiting room area, a volunteer work area, some storage space, and very importantly, a meeting room for the use of group counseling and special instructional sessions.

Also, for the purpose of confidentiality, note that a separate exit has been provided so that the counselee need not leave the counseling center, after a counseling session, through the waiting room entrance.

This pilot counseling facility in the Miami area will also provide sufficient space for a library of books, pamphlets, papers, and other materials which will be utilized regularly in the counseling process. Competent counselors will reach out by telephone, and also through the mails, to people all over the nation who are oppressed by moral and personal problems and who call in or write to seek help. In next month's Newsletter

we hope to be able to announce the main telephone number of the center.

Because we are receiving so much correspondence nationally, especially from people who desire to find a way out of homosexuality, it is important to provide sufficient administrative and secretarial space in this initial counseling center. The southeast wing of the facility has been allocated for this purpose.

This counseling center is located on the second floor of an excellent modern building. We are more than pleased in every way with the facility, and regard it as a provision of God.

## New Director Outlines Counseling Program

Anita Bryant recently introduced the Reverend David R. Renfroe to the press and the media as the new Director of the counseling center that she is opening in the Miami area under the auspices of Anita Bryant Ministries.

"Even though the counseling center will be operated by Christians," explains Miss Bryant, "its services will be open to people of all faiths. No attempt will be made to counsel any persons except those who first recognize their need for help, and then explicitly request it."

David R. Renfro then briefly outlined the counseling program and the responsibilities he would assume as Director.

Former minister of the Calvary Bible Church in Williamston, North Carolina, Reverend Renfroe comes

from a highly qualified background of various Christian counseling experiences and professional studies.

His following comments explain how he perceives his role and God's purpose for this specially designed counseling center:

"A totally new and crucial segment of the Anita Bryant Ministries is about to become a reality. This is the much needed counseling center that is designed to deal with the large volume of earnest, yet troubled people seeking guidance and meaning for their lives. Hopefully within the next couple of months we will have completed all necessary planning and have the counseling center operational.

"Our purpose for this center is not to establish a clinic with a sterile and aloof approach to fellow humans who may be experiencing all manners of

difficulties. Rather, we are going to establish a setting where an individual can find understanding, love, warmth, and acceptance with total confidentiality. However, this setting is to be structured in such a manner as to bring about radical and permanent healing of the whole person. Necessarily then, this will include an honest confrontation with the client along structured Biblical lines.

## Realistically Speaking

There are a great many different opinions concerning counseling — who needs it, what it is, and who should do it.

There is the humanistic viewpoint that man is the center of the universe, and has the solutions to all of his own problems. By means of education, science, behavioral studies, and control of the environment, all human inadequacies and illnesses can be overcome.

Humanistic counseling generally goes back to roots associated with Sigmund Freud. He's the fellow who tended to trace all problems back to sex and childhood. Also, he taught that religion and Christianity are little more than crutches for mentally sick people.

Freud has many descendants today. They are practicing psychology all over the country. Their entire effort is within a humanistic framework which excludes God and spiritual values from the healing process.

The other major approach to counseling is the one which recognizes God at the center of the universe and which approaches human problems in terms of man's relationship, or lack of relationship, with the Creator.

This Godly approach to counseling believes that the basic ingredient in healing a person is the establishment and maintenance of a proper relationship with God Himself.

This approach distinguishes two major life systems. First, the "delusion system" which entraps millions.

It is a way of living without facing up to the truth. The key words are deception, delusion, and defeat.

The other major life system is called the "truth system." The basic feature of this system is that to the very degree that truth displaces and replaces deception, the individual will enjoy healing and ultimate wholeness.

The Anita Bryant Ministries Counseling Center which is being established in the Miami area is based on the God-centered approach to counseling and healing. It will present a truth system as the pathway to abundant living.

God is the source of all truth and, realistically speaking, the best life, now and hereafter, is for those who align themselves with His truth.

"The counseling center will provide a ministry that recognizes the preeminence of Jesus Christ and the proper application of the inviolable Word of God to man's deepest needs.

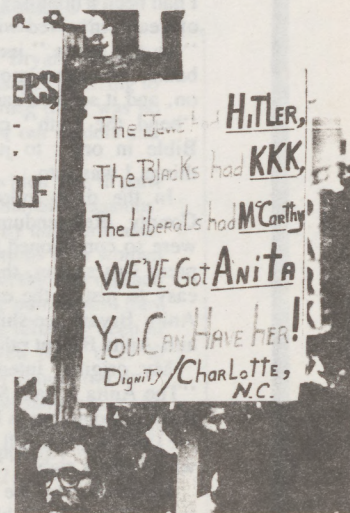
"Pray for this ministry, for me as the new Director, for the entire Anita Bryant Ministries staff, and particularly for those who are going to come to us with their special needs."

## Ex-Homosexual Pastor Writes Anita...

Dear Anita & Bob,

While pastoring a liberal gay church in rural Pennsylvania, I had the occasion to read "The Anita Bryant Story." I must admit that my original intention was to discredit what was written in the book in order to justify not just the homosexual lifestyles of my congregation, but my own gay lifestyle as well.

I had been ordained a Christian minister in 1976, and had indeed been born again, accepting Jesus Christ as my Savior, but was led by the doctrines of liberal and homosexual churches rather than by God's Word. I had been a homosexual for a number of years, involved with all aspects of "the gay scene," including the bars, baths, liberation movement, and so on, and it seemed easy at the time to "bend the truth" contained in the Bible in order to justify the many things I was into.

In the days following the Dade County Referendum, homosexuals were so conditioned by what the gay press was saying, that it was all too easy to justify the existence of anti-Anita Bryant tee-shirts and buttons, anti-Anita Bryant rallies, etc. as well.

My original intention in reading "The Anita Bryant Story" was not a righteous one, but as I read your book, the Lord began to tell me, "You know what? She's right."

Remembering the old saying that you can use the Bible to prove *anything*, I attempted to find the Scriptures that would discredit your words,

as well as verses which would conflict with those that were telling me that homosexuality was a sin. As difficult as it was, I had to admit that it couldn't be done!

Through your book, Anita, I was convicted into receiving Jesus as Lord of my life, knowing now that when He calls us to accept Him as Savior, we are also called to come under His loving Lordship as well.

In following Jesus and accepting His Word as being totally inspired, I can no longer pretend that I Corinthians 6:9-11, Romans Chapter 1, Leviticus 18:22, and other verses which express God's view toward homosexuality do not exist, for if we accept all Scripture as being inspired (2 Tim. 3:16), we can't conveniently ignore verses which we find difficult or contrary to our lifestyles; *commitment* to Jesus Christ means that we are to accept Him on *His* terms, not ours.

All too often we find that "people won't listen to the truth, but will go around looking for teachers who will tell them just what they want to hear" (2 Tim. 4:3 TLB). This, unfortunately, is being propagated in the homosexual church today. If, indeed, we *truly* accept Jesus as so many homosexuals profess to do, then we must admit that He knows what's good for us better than we know what's good for us.

Anita, I had been searching for a long time to find "gay liberation." Through "The Anita Bryant Story," I found that the only true gay liberation

which exists is liberation in Christ, for "if the Son sets you free, you shall be free indeed." As much as the gay church quotes this verse from John Chapter 8, they seem to ignore the rest of the words in the chapter, which tell us that we *can't* go on living in sin and yet claim to be committed Christians. We can only find *true* liberation by following Jesus' commandment to abide in Him, by repenting of our sins, and trusting Him to lead us in the paths that are right.

After reading your book, my eyes were opened up to see that the gay scene is *not* gay; those looking for love will only experience lust and rejection; those yearning to be free will only end up trapped in their own sins.

The sad thing is that those who are trapped by a gay lifestyle have deceived themselves into believing that they are happy and that what they are doing is pleasing to the Lord. With our prayers and efforts to bring the Word to homosexuals, however, there is still the chance of reaching those who are now only fooling themselves.

I have been blessed with the opportunity to reach gay people with the true Gospel of Jesus Christ, and have seen that as Corrie Ten Boom once wrote, "there is no pit so deep that God isn't deeper still." No matter how low a person might go or how involved in the homosexual lifestyle people might get, the Lord can *always* reach down and pull them out if only they'll give Him a chance. The important thing is that if a gay person chooses to accept Jesus, it must be done on *His* terms.

In these days when too few people have the courage to speak out in defense of God's Word and His righteousness, I am thankful that the Lord has led you to take the stand you have taken in His name. Sometimes, when gay people hear the truth, it can really hurt them at first, but in the end, we can know that it is the truth that will set us free.

Know that despite any tee-shirts, buttons, rallies, articles or anything else which have taken the "anti-Anita Bryant" stand, there are many of us who were in the gay scene that you have reached. For that, I'm grateful, and my prayers are with you as you continue in this ministry.

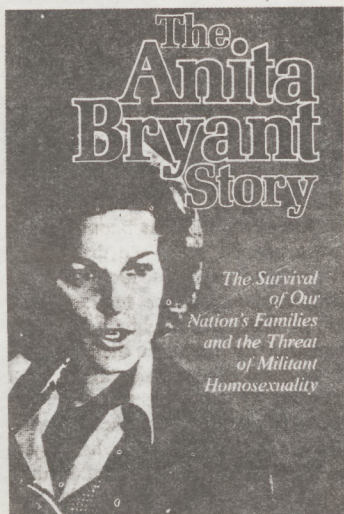

## God And Homosexuality

Men do shameful things with each other, and as a result they bring upon themselves the punishment they deserve for their wrong-doing. 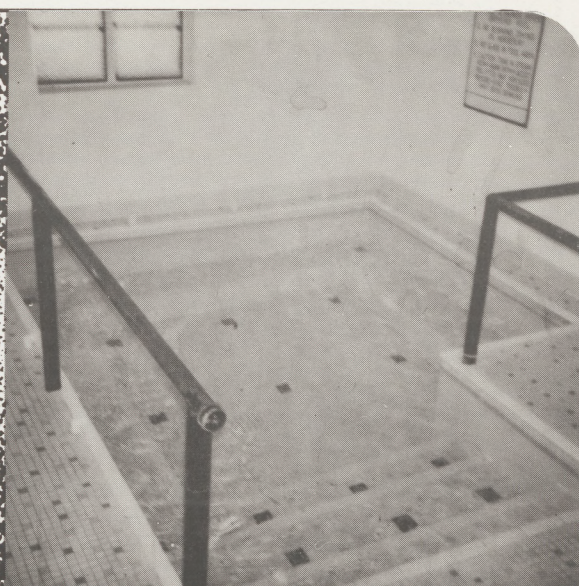
