### Your '98 Pride is this month

Ce Ce Peniston, Men Out Loud and CHANGE are all headliners at this month's Pride Parade and Festival.

Saturday, April 18, a new generation of Pride takes off with "Pride 98... A Gateway to Change". The parade steps off from Park Central Mall at 10 AM and heads south to Margaret T. Hance Deck Following the parade, at approximately noon, the festival begins at the Deck Park and runs until midnight. Advance tickets are \$8 and are available at many community businesses; at the gate admission will be \$10. All stage shows and events are included in the one ticket price and kids under 12 are free.

The main gate for the festival will be on Central Avenue, just under the bridge. It will be well signed and handicapped accessible. There will be an additional gate at Second Street and Moreland.

#### Check the Pride Web Page

At WCN press time, Pride was still negotiating for Special Needs and VIP parking, along with a shuttle service to run between the festival and area parking lots. Various other details and schedules were also up in the air as this story was being written. So, readers are advised to consult the Pride page at www.azpride.com for the latest information, as it becomes available.

A new feature this year will be an area called The Bistro. The key word here is "relaxed". Outfitted with tables and chairs, it will be an area where you can take a break, enjoy some refreshments and maybe have a nice conversation with friends. The music here will be mainly of the acoustic sort, with some Karoake throw in just for fun. The Bistro will be located on the big patio area just south of the library.

#### The Dance Tent

Here's another change. The dance tents are gone. Instead there'll be dancing in the streets - actually, dancing in the

First Street from street. Moreland south to Portland will be blocked off for dancing. Hi-Nrgy (or, "club") dancing will be featured from noon to 3 PM, and again from 9 PM to midnight. Country and Western dancing will go on from 3 PM to 9 PM.

#### The Main Stage

Continuous entertainment and events will take place on the Main Stage. Lots of local acts, and some

national headliners will be featured. Acapella group Men Out Loud will perfom at 7 PM (approximately). Pop diva. Ce Ce Peniston will take the stage after Men Out Loud. There will be an Western and hour of Country entertainment from 3 PM to 4 PM. The crowning of the 3MGP winners will take place sometime after sun down.

#### Some Things Don't Change

Of course there will be plenty to eat and drink, including cold beer. And the vendors will be there offering all manner, of community goods and services. This is also a great place to meet many of the community organizations which will have booths set up. WCN will be there, so be sure to drop by and fill out one of our Reader Surveys.

#### Parade Staging Change

The parade will begin staging at 7:30 AM on Catalina Drive between Central and Third Avenues; this is the street at the south end of Park Central Mall. Entrants are reminded that they will have to furnish a list of marchers names (no addresses, etc) and/or proof of insurance along with a driver's license for motorized units. Dykes with bikes, can sign in and ride for \$10. According to the manager, Starbucks Coffee, adjacent to the staging area, opens at 6:30 AM on Saturdays - so coffee and a nosh will be

available for parade workers. Walk up parade entries will be accepted, however they will pay a premium entry fee; preevent registration forms are available on the Pride web page.

#### **New Publication for Alternative Families**

Alternative Family Magazine, a new national bimonthly publication for gay, lesbian, bisexual, and transgendered parents and their children, hits bookstores this spring. "At a time when our families are on the cutting edge of the battle for GLBT rights, we'll be telling the stories of ordinary people doing extraordinary things," says publisher Kelly Taylor.

In addition to essays and photos depicting the lives of GLBT parents and their children, the magazine will cover legal developments, reproductive issues, and social and behavioral matters. It will also feature household hints, favorite recipes, and book and video reviews.

In the Kids' Room, children can find coloring and games pages, a penpals page, and a section where they can publish their artwork and writing. Rounding out the magazine will be a classified section and resource guide specific to the needs of GLBT families, including a personals section for people seeking partners with a shared interest in children.

"We're looking forward to developing a very special interactive relationship with our readers, and together our families will grow," says Taylor. In addition to its regular contributing writers and columnists, she sees readers as providing a major portion of the magazine's content in the future. She envisions the magazine as one-stop shopping for resources on GLBT parenting, and a website is in the works.

As a family magazine, Taylor has made a conscious decision not to accept alcohol, tobacco, or sexually explicit advertising -- a mainstay of many GLBT publications. While this presents an initial challenge, Taylor says it also offers an opportunity to pioneer ad sales with clients who haven't been traditionally attracted to

other GLBT advertising opportunities.

oing to elistic

Initial response to the magazine has been overwhelmingly positive from parents to publishing industry executives to potential advertisers. "The National Center for Lesbian Rights reports that there are anywhere from 6 to 14 million children living in lesbian and gay families," Taylor notes. "These families deserve a voice of their own. I think we're filling an important niche by serving their families' needs at a time when efforts to gain societal and legal recognition for our families are at an important crossroads."

The first issue features a story about a remarkable 11-year-old girl and her lesbian moms. Sol Kelley-Jones of Madison, Wisconsin has spoken out at legislative hearings, conducted a school survey about homophobia that was entered into the Congressional record, spoken on a panel with Martina Navratilova, and been given awards for her activism by the ACLU and the National Organization for Women. She epitomizes the bravery of parents and children throughout the country, Taylor

The March/April issue also features lengthy selections from the awardwinning photo and text exhibit "Love Makes a Family," a story on openly lesbian evangelist and musician Marsha Stevens, and a feature on a kids' summer camp for GLBT family members. It also marks the debut of columns by psychologist Greg Shears and Attorney Kate Schreurs.

# March On Washington Spring 2000

NEWS RELEASE from the Human Rights Campaign March 5, 1998

LETTERS TO THE EDITOR

We believe our community has an opportunity to welcome the new century in a fresh way with a Millennium March for Equality in the year 2000. Inside and outside of our organizations, we have felt much enthusiasm around the country for the proposed march.

In the year 2000, the entire nation will be looking for new trends and fresh messages. We have an opportunity, if not an obligation, to use this wave to effectively shift the paradigm of perceptions about gay people. Given that, we concluded early involvement could provide an opportunity to shape the messages such a gathering will impart to the nation and to avoid some of the pitfalls of prior

We believe that in the early 1990s, gay America entered an entirely new period that has gone largely unlabeled and unanalyzed. Shaped partly by the AIDS crisis and partly by the groundswell of people coming out and living honestly, the priorities of our community have changed dramatically. We are looking for ways to find stability in our relationships, health, homes and communities. We are in the middle of a gay baby boom. The desire to legally marry has emerged as an extremely important goal for many gay Americans. Many of us are returning to the churches of our youth or finding new ways to express our spirituality.

We are also living in a time when, despite the best efforts and significant financing of the extreme right, the country is moving forward. We have seen important shifts in public attitudes and institutions, particularly in the workplace. The journey is not without struggle and setbacks, but we are moving at a speed inconceivable even a generation ago.

The shift we have described has NEVER been effectively communicated on a mass scale to the American people. A Millennium March provides a remarkable opportunity to dramatically demonstrate what it means to be gay in this nation at the turn of the century. This march is an unprecedented opportunity to celebrate our diversity as a community of family, spirituality and equality. This march should be absolutely inclusive -- gay, lesbian, bisexual, transgender and straight.

THE PRACTICAL BENEFITS OF SUCH A MARCH ARE MYRIAD.

\* This is a tremendous opportunity for every LBGT organization to build membership. People will come in huge numbers for this march, and they will be looking for a variety of activities. Groups could plan anything from street fairs to forums, workshops to cultural events.

\* Most people who took up gay civil rights work in recent years were inspired at a march on Washington. Everything from ACT-UP to the "Free Sharon Kowalski" movement was born out of marches on Washington. No matter where the passion goes, it is important to provide a medium where new leadership and ideas can spawn.

\* The year 2000 is a presidential election year and the LBGT segment of the electorate will be courted as never before. This is also an incredible opportunity to organize people to work in campaigns and to lobby their members of Congress when they are here.

\* Even those people who cannot travel to Washington will be able to share the march on television, perhaps holding house parties for friends and families.

\* Although no decisions have been made regarding excess revenue, a national march is probably one of the few ways to raise the kind of funds needed at the statewide level.

Over the past five years, we have invested heavily at the state level, responding to crisis after crisis. We have channeled thousands of dollars in

these battles and for the most part, we have won. All of the statewide anti-gay ballot initiatives have been defeated and, thanks to the work of the American Civil Liberties Union, the Colorado Legal Initiative Project and Lambda Legal Defense and Education Fund, the U.S. Supreme Court ruled favorably in the Colorado

But our statewide organizations remain in dire need of investment. The leadership in many states is excellent, but with a few notable exceptions, most of our statewide organizations are in severely lacking in capacity-building and general investment. Moreover, they need pooled funding for polling, research, message development and a network of crack lobbyists.

Some critics of the march have used the recent loss in Maine as a basis to argue that a national march shouldn't take place because some other plan would produce the investment needed at the state level. We believe this is a faulty analysis. First, there are millions of dollars available in the community not accessed by any organization. The last march should be instructive. Gay Americans spent more than \$170 million to attend that march. With proper planning, some of this revenue can be captured by the march entity.

Others have argued a Millennium March would detract from a 50-State Action being planned for 1999 by the Federation of Statewide Organizations. We see the two events as complementary. And we believe that state actions alone will not capture the imagination of most LBGT Americans, nor will they slake the desire for a national millennial event. We believe the national march is the natural follow-on to bring energy and excitement to these proposed statewide actions.

Critics of the march concept have argued that the statehouses are where all the action is, but the fact is we need to be strong, bold and strategic as a movement at every level. The statehouses are where the state action is. Congress, the executive branch and the U.S. Supreme Court are alive and well and able to do harm and/or good on any given day. And gay citizens of many states will never win their civil rights without a national effort. One of the best examples is AIDS. Congress appropriated \$1 billion HIV/AIDS last year. Imagine where we would be today if the states had to fight this battle alone.

We think a national march in the year 2000 is an incredible opportunity for all of the above reasons. Rather than become mired in the mud fight that has emerged among those who would criticize this idea, we would like to invite them -- and you -- to participate in what we believe will be the most exciting demonstration of our unity and power at a seminal moment in time.

### What's up?

Research by the Public Policy Institute of the American Association of Retired Persons, has found that 2 million elderly people at or below the poverty line are using 50 percent, or more, of their yearly income for medical expenses. On March 5th a newly formed 17-member bipartisan Medicare Commission met with President Clinton for the first time to address the future direction of Medicare.

Boy Scouts lose ban on gays

On March 2nd, a New Jersey state appeals court ruled that the Boy Scouts of America discriminated against James Dale when he was expelled as Scoutmaster eight years ago for being gay. The court stated that stereotypical notions about homosexuals must be rejected.

**Biological variance** 

Dennis McFadden, a professor of experimental psychology at the University of Texas-Austin, reported on March 2nd and in the current Proceedings of the National Academy of Sciences, that a study he headed indicated that the hearing of lesbian and bisexual women tends to be a bit more like men. Sandra Witelson of McMaster University, who studies the relationship of brain anatomy to sexual orientation. said that the results support the theory that differences in the central nervous system exist between homosexual and heterosexual individuals.

#### Intolerance thrives in church

The 180-member executive board of the statewide Baptist General Convention of Texas voted March 3rd to disassociate itself from university Baptist Church in Austin because of the church's active support of homosexuals. Committee head, Charles Davenport, a Fort Worth pastor, led the committee in drafting the motion. ### To Your Health

Let's continue the discussion on estrogen....

In March we talked about the good things estrogen replacement does for our bodies when we are postmenopausal - less "hot flashes", vaginal dryness, urine incontinence/leaking. Also, estrogen replacement decreases how fast we lose bone calcium and bone strength. Estrogen will help keep our hearts healthier, too.

What are the drawbacks to taking estrogen? (You know, to every positive there is a negative.) Any history of abnormal genital bleeding should be evaluated BEFORE taking estrogen. Any history of blood clots in our legs/thrombophlebitis or other clotting disorder should be discussed BEFORE taking estrogen. Classicly, estrogens tend to increase or promote recurrence of these problems.

And (of course) do not take estrogen if you may be pregnant (of course, then you WOULD NOT be postmenopausal.) Other more controversial issues are if you have had uterine cancer or breast cancer. Please, please discuss this long and hard with your health care provider. There are good arguments of both sides of the fence.

Estrogen therapy can be started during menopause when you are having hot flashes and other symptoms. It can also be started anytime after this - in your 60's, 70's, 80's plus. If your uterus/womb is still with you (no hysterectomy) then you will need to take progesterone with the estrogen.

Some health care providers will "cycle" the hormones so you could possibly still have menstrual periods, OR the estrogen and progesterone are taken together everyday. Sometimes we need different doses of estrogen and progesterone to feel our best, so our health care provider may need to adjust the hormone doses a few times. If any vaginal bleeding occurs after the first 6 months, see your health care provider (Do you need a uterine biopsy?)

There is much literature available on "natural" hormone therapy and menopause treatment. Herbs, homeopathic remedies, etc., are available. A naturopathic or homeopathic health care provider would be a good source for guidance.



Could it just be chance, or is it simply another example of how women are given low-paying jobs and kept there by a system that values men's work over women's work? That a legislator could even come up with the "take a pay-cut" is unconscionable.

Better yet, grab yourself a

husband. Before we get into the issue of personal freedom, let's tie this into the issue of men's vs. women's work again. Basically, this lawmaker is implying that of course a MAN makes enough money to support a family. My question is, why can't a woman? You don't hear any low-income, struggling men being told to marry a woman to solve their financial difficulties. Probably because A. men get paid more just because they are men and B. men aren't supposed to have to depend on women. My, my, my, gendering our society by who gets to make the money. Who'd have thought it?

And we haven't even touched the issue of her personal freedom in loving whom and when she chooses. It looks to me as though the man or men in her life who fathered her children obviously didn't see himself as a means of support, or she wouldn't be in this predicament. Why should she be compelled to select a mate based on his ability to financially support her? Isn't the real problem a society that doesn't value women or women's work enough to insure them adequate wages? Isn't the real problem a society that tracks women toward low-paying jobs and in essence tries to keep them there? Another tool of the patriarchy to keep women firmly subordinated, perhaps? You decide.

# Margarethe Cammermeyer tells SMR RV Park she's "Running for Congress to Win"

One of three open lesbians running for U.S. Congress this fall, Margarethe Cammermeyer visited Superstition Mountain Resort in Apache Junction Feb. 28 to tell more than two hundred cheering residents that she's "running to win."

Retired Army Colonel Cammermeyer fought for her military career and won when she was discharged in 1992 after she "told the truth" during a security clearance hearing and said that she was a lesbian.

She wrote the story of that fight in her autobiography, Serving in Silence, (Viking, 1994), which Barbra Streisand made into a television movie of the same name that won numerous awards. Glenn Close and Judy Davis portrayed Cammermeyer and her lover, Diane.

Diane was "home baby-sitting her mother," Cammermeyer told the audience. "I'll tell her you acknowledged her and asked about her. She stays out of this race. She is my center, my reality. Without her I'd probably be a general today, and I'd be a lousy general," Cammermeyer joked. They've been together ten years.

The film was "pretty close to reality, though we retained our privacy on some issues. The filmmakers kept trying to find something juicy. Diane and I did exchange buckle rings, but it was nothing like the movie. The situation with my father was exactly as shown in the film. He became demented and then he died. We never really did work things out."

She worked closely with Glenn Close to make sure that the film was accurate about military details. "I taught her how to walk like a colonel, as if she was on a mission. I was more concerned that she be a good colonel than a good Grethe." Cammermeyer cited several instances in the film that make her cringe, where the civilian Canadian salute was used by mistake, for example, and where the wrong uniform was worn.

"Overall I'm very pleased with the film. I didn't want to see it made, but when Barbra Streisand calls, you answer, and she told me that this issue was the most important civil rights issue of this decade. I always very naive but I did know who Barbra Streisand was. After all, I'd seen Yentl. She understood discrimination."

Cammermeyer said she truly did not know that there were so many gays and lesbians in the military before she became the center of the controversy. "If being gay was a problem in the military, there would be no gays left in the military because the services weed out those who cannot perform."

Her case was the foundation for the "Don't Ask, Don't Tell" policy of President Clinton. In June 1994, she was allowed to rejoin the Washington State National Guard after having been separated from the service for 25 months, and she served a total of 31 years before her retirement in March 1997.

When she'd been discharged for being a lesbian in 1992, she'd won such honors as the Bronze Star for Meritorious Service in Vietnam, the 1985 Administrators Award for Excellence in Nursing (out of 34,000 RNs in the Veterans Administration), and Woman of the Year by the Women's Army Corps Veterans.

Her M.A. is from the University of Washington in neuroscience, specializing in epilepsy, and her Ph.D. from that institution was awarded in 1991. Born in Oslo, Norway, in 1942, she became a U.S. citizen in 1960. She is also the mother of four

s o n s .
"Coming out to each one separately was a real trauma," Cammermeyer said. "But they said afterward they'd already known for years—why didn't they tell me!"

When military

the military ruled the original policy under which she was discharged was unconstitutional and she was reinstated, the decision was allowed to stand and thus became military law.

"I believe in poetic justice. I would love to be on the Armed Services committee reviewing military policies when the law set by my case comes up for review!" Cammermeyer said.

She says that if elected, she would not be going to Congress with a "gay agenda, whatever that is. Pat Robertson says that feminism wants women to kill their babies, leave their husbands and become lesbians. Some say that's the gay agenda. Now if you ask if I'm going to Congress to fight discrimination, you're darned right."

She said that her background as a mother, nurse, and health care administrator gives her the credentials for Congress. "Health care and education should be a basic right for everyone." Older citizens should be very concerned about education, Cammermeyer stated. "On the basest level, the little hoodlum stealing your car didn't get a good education."

She would look at military spending and see "which resources are still based on the needs of World War II and which bases exist primarily for the needs of their communities rather than for the needs of the military. One F-14 would pay a year's education budget.

She is particularly concerned about changing campaign financing. "I absolutely hate having to make 100-120 cold calls for money every single day, but that's what it takes to run for Congress today. The estimated cost for a Congressional campaign is at least \$1.3 million, and for Senate \$6-12 million. That cost is primarily for the media blitz at the last minute to counteract all the negative stuff that gets thrown at the end."

She would be open to an overhaul of Social Security, "but only if we keep the promise we made to the current generation that we would provide this security net. The phase-out would have to be gradual."

Her target in the second Congressional district of Washington is two-term incumbent GOP Rep. Jack Metcalf, "a very nice man who is one of the dimmest of the dim bulbs in Washington. He only won the last election on absentee ballots—the Democratic candidate was already in Washington preparing to be sworn in when the last winning 1,200 votes were found." Metcalf's record is 100% compatible with the views of the Christian

Coalition and zero according to the Human Rights Campaign's 1996 legislative scorecard, Cammerme yer said.

The district is the northwest corner of the

state, 96% white, average age 33, average income of \$28,000, "with everyone from rednecks to Native Americans to farmers to Boeing workers to the Aryan Nation represented," she characterized the demographics.

"It was Democratic for 25 years before Metcalf, and it went for Clinton and for (Democratic liberal governor Gary) Locke last election. I believe the people will vote

Democratic again. They're just not sure yet that they want a queer to represent them in Congress. But I am running to win."


Cammermeyer knew about the Apache Junction RV park from a friend, Care DeLeeuw, who owns a lot in SMR. She knew that the park residents had voted for eleven women role models for their street names, and one of those names was Margarethe Cammermeyer. She stood below that street sign for hours Feb. 28 and allowed residents to have their pictures taken with her. She was also treated to a golf cart parade, "the closest I ever got to a military parade," she said, laughing.

Those who want to support her campaign were asked to send checks made out to C2C (Cammermeyer to Congress), P.O. Box 577, Langley, WA 98260, and to "spread the word on the internet, to your friends, in letters to the editor, in every communication avenue you have. The Christian Coalition is mounting its own campaign against me, you can be sure."

The other two open lesbian candidates for Congress are Christine Kehoe, city councilwoman from San Diego, CA, and Wisconsin State Rep. Tammy Baldwin.

The openly gay Congress members now in office all came out after having been elected while in the closet, and several, including Barney Frank and Steve Gunderson, were re-elected to Congress after coming out while in office.

# Center remodels; offers new

Throughout the months of February and March, volunteers could be found busily remodeling the interior of the Valley of the Sun Lesbian and Gay Community Center in time for the grand opening, which was held on March 29. Their efforts have made the Center a pleasant place for programs, meetings, or just relaxing.

In February, we reported that the Center had moved to a new location in two suites at 24 West Camelback, next to Obelisk bookstore. The Center's new space required extensive work before it could be opened to the Lesbian and Gay community. In order to open as quickly as possible, the Center remodeled one suite first. Now that this portion of the Center is open, work will proceed on the second suite.

Volunteers the began remodeling by ripping up the carpeting, which was glued to every inch of the floor. Next, the volunteers switched their efforts to the walls, removing paneling, patching cracks, sanding rough areas, and painting. Talented carpenters in the community even added a wall to partition off a portion of the suite. Meanwhile, other volunteers laid linoleum in the entryway. The new carpeting was added next.

On a recent Saturday, the following people were busy patching

and painting the walls: Community Center board co-chairs, Becky Hansen and Patrick Whorton, Center director Lyle Miller, Anne L'Ecuyer, who heads the BJ Budd Memorial Library at the Center, and board members Mary Bucci, Gail Paul, Vern Johnson, Will Conway, and Jon Gates. Several other people have donated time to the remodeling efforts as well. Ms. Hansen states that additional volunteers are always welcome.

In addition to the numerous physical changes, the Center is making some changes to its mission. While continuing to operate the Switchboard, coordinate the Valley One in Ten youth program, and provide meeting space for various Community groups, the Center plans to offer new programs as well.

The first new program, a four-session mini-course, began on March 26th. According to Anne L'Ecuyer, the course, entitled "Writes of Passage: The Role of Literature in the Gay and Lesbian Community," is introducing participants to excerpts from the work of a variety of lesbian and gay authors.

The course is being moderated by Robert Pela, a book critic for the Advocate and theater critic for the New Times and KJZZ, the local National Public Radio affiliate. "Writes of Passage" was full in advance of the start date, but Ms. L'Ecuyer states that it will be offered again at a later time.

On the final evening, course participants will attend a lecture by long-time author Quentin Crisp. The public is also invited to the lecture, which well be held on April 3, 7:30 p.m. at the Phoenix Museum of History. Mr. Crisp will also sign books at the Arizona Book Festival At

Politician's make all the rules and spend all the money so I hold them directly responsible for the death of this women who was frantically searching for a place in which she could stay alive.

This is so very basic. It is not asking too much for a woman who is seeking it, to have a bed for herself and her children, a place where she will not fear a knuckled fist in the mouth, a bread knife in the gut or a shot in the head.

It is so very basic that children not watch their father beat the shit out of their mother because she 'talked back'. Politicians must get back to basics RIGHT NOW and protect women's lives.

I don't make much money, (what woman earns equal pay for equal work in this state?) but I pulled out my checkbook and sent the Sojourner a check. I'm asking all my friends and co-worker's to invest in women's lives by supporting a place for women to go, not where they will lounge around and get treated like a

queen, eating bon-bons and watching soap opera's, but a place where they can go so they won't be killed.

Carrie told me that the Sojourner Center has opened the Sojourner Thrift at 1637 E. McDowell Rd. in Phoenix, where women who are trying to build new lives through the Sojourner Center, can go to get, for free, the necessities to set up a home for themselves and their children. If you have 'stuff', bedding, kids and women's clothes, toys, anything useful to a woman with nothing, take it there. Although women from the shelter get things free, all proceeds from items sold to the public go to support the Sojourner Center itself.



## Tax break for lesbians?

Here's an interesting "Catch 22" situation, which could work for us for a change. It exists in current federal income tax law, and regards a new credit available for expenses incurred in adopting a child after 1996.

The credit - which is 100% of most expenses and as high as \$6,000 in total - can be claimed under federal law by taxpayers who are married or unmarried. However, a specific limitation denies the credit for expenses connected with adopting your "spouse's child"; this is often a formality when couples have children from previous marriages. The intention, obviously, was to limit the credit to adoption of parentless

children, but that isn't what the law says. The law is silent on disallowing expenses necessary for a "co-parent" to adopt his or her unmarried partner's child, regardless of whether we are talking about same, or opposite, gender couples.

An interesting sidebar to this dilemma is that there is already another federal law, DOMA, which essentially states that a same gender couple CAN'T possibly be considered "spouses" under federal law. This would seem to enforce an assumption that the adoption credit *should* be available to such couples, since the only prohibition involves adopting a spouse's child!



### What is Mine: Wellness

We hear the word "health" a lot; there is more and more emphasis placed on "healthy diet", "healthy lifestyle", etc. in our daily lives. We usually associate health with good fitness, but originally it was defined in terms of illness. The first doctors concentrated on making sick people well, and that meant that health was indeed nothing more than the absence of disease. As time progressed and every day was less and less a constant struggle against the ravages of a number of diseases, the focus of the medical community shifted to the prevention of illness, expanding the definition of health to refer to "the state of optimal physical, mental and social well-being"

Today's definition of health generally includes the concept of "wellness". Wellness is more about the state of being that enables you to reach that potential optimal health. Wellness has to do with feeling good about you and with having goals and purposes in It spreads itself across all categories of life and affects your perceptions about your abilities, attitudes, and beliefs. A well person is more likely to assume responsibility for their own health, and creates opportunities for improving their health. Well people generally feel that they have some significant amount of control over their well being in the of intellectual, social, emotional, physical and spiritual health. They create positive patterns in their lives and feel confident that they CAN make a difference. Wellness is about many of the intangible things that make us motivated, happy, creative, and satisfied with ourselves because we have taken steps to control our own well-being.

It is not about grinding out one hour on the treadmill each day, or measuring exactly one tablespoon of butter, or forcing exactly thirty minutes out of the schedule for quality time

with the kids. Part of this satisfaction is being happy with our efforts and accepting of our outcomes. It is striking a happy medium of suitable efforts and sacrifices and being able to live with whatever outcomes we can

As an example, a person may want to be more physically active. She could pay to join a gym and get up at 5:30 in the morning to make a highimpact aerobics class every day. She barely makes it to work on time, has no chance to eat until noon, and doesn't really like the music for the class, but she feels that this method of activity must be what she HAS to do. In the long run, this does not contribute to her sense of well being because of the stress and disruption in her life. For wellness' sake, this same person may choose to take a long stroll alone or with her significant other every evening. She could enjoy the feelings of stretching her legs and lungs, take the time to "decompress" from a workday, and enjoy the scenery. She could put the music of her choice on the sound system at home and make the housework into an activity session. She could choose an activity that she enjoys and find a group of like-minded people to "play with". She should not feel compelled to follow someone else's idea of what activity should be, not to meet some standardized outcome of weight lost, heart rate achieved or calories burned. Does this example help you to understand what wellness might be?

Wellness is what health professionals, at the core, need to promote. Wellness comes from within the individual, not from some externally prescribed program or achievement of some goal set by science or society. Wellness is individual, personal and belongs to the person as her choices make a difference in her life and in her relationship with others and the environment.

#### Unmarried partners cleared for benefits

It is legal for Pima County to offer health insurance benefits to the unmarried domestic partners of county employees, a judge ruled yesterday. The ruling came eight months after domestic partners were to begin receiving benefits under a new county

Cheers and sighs rippled through a row of the policy's supporters when Judge Allen Minker, of Greenlee County Superior Court, announced his decision. Tears pooled in the corners of Ana Lozano's eyes

"I'm just happy," said Lozano, one of about 100 county employees poised to take advantage of the Her domestic partner, benefits. Matilde Slate, will receive health insurance benefits through the plan as soon as the county implements the policy.

That may be as soon as the next pay period, said Kevin Flynn, the county's human-resources manager for compensation and benefits. 'Somebody's got to tell me in writing when to jump; then we'll jump," Flynn said.

The Board of Supervisors approved the policy in March of last year. Employees seeking the coverage signed affidavits saying, in part, that they and their partners lived together, were not married, shared expenses and were not related by blood.

On July 1, 97 county employees were set to receive the benefits. Of those who initially signed up for the benefits, 90 percent did so for partners of the opposite sex. Only 10 signed up for same-sex domestic

Taxpayers complained about the policy to the County Attorney's Office, which filed suit to stop it in June. The subsequent legal struggle pitted the Pima County Attorney's Office against its usual client, the Pima County Board of Supervisors.

Yesterday, Deputy County Attorney Chris Roads argued that state law doesn't allow the county to define "dependent" as it does under the policy. "Nowhere can we find a definition of the term 'dependent' that is sufficiently broad to include the board's policy," Roads said.

Policy supporters "do make a very compelling argument as to why it's the right thing to do to provide insurance to domestic partners," Roads acknowledged. "The state law doesn't necessarily support what's the right thing to do."

Grace McIlvain, the attorney for the supervisors, argued the same right that allows the county to offer insurance to any dependents of county employees allows them to offer the benefits to domestic partners. "The county decided long ago that dependents would include spouses and children. No one ever challenged the board's authority to define the term at "If the that time," McIlvain said. county had the power to define the term initially, certainly the county has the power to expand that definition."

Minker offered explanation of his decision. ``The legal authorities do not support the position of the county attorney. The Board of Supervisors did act within their authority on this case," he said.

The decision apparently will keep taxpayers from filing their own legal challenges to the policy. would expect the taxpayers to be upset about this. But this decision pretty much precludes any other lawsuits," Roads said.

He added that he does not know whether County Attorney Barbara LaWall will appeal the decision. He expects her to decide within two weeks.

"The big issue is whether Barbara LaWall will appeal or not," Supervisor Raul Grijalva said. "I hope she doesn't. Both sides have already expended some taxpayer money."

The county expects the policy to cost about \$120,000 per year. The city of Tucson adopted a similar policy in July.

## The Power of One

In 1996 the United Methodist Church held a General Conference whose mixed members of clergy and lay people voted 577-378 to declare that homosexuality is incompatible with Christian teaching and therefore prohibited ceremonies that celebrate homosexual unions.

It only takes one person to make a difference, to fight for 'loving all' instead of 'loving those I approve of'. Omaha, Nebraska's senior Pastor Jimmy Creech has made a difference by conducting a lesbian unity ceremony. As a result he could have lost his ministerial credentials.

However, on March 13th a panel of 13 Methodist's ministers selected to hear the charges against him, cleared Rev. Creech of disobeying the denominations ban on gay rites. According to church procedure, nine of the 13 panelists had to agree to sanction Creech and only 8 did.

The Rev. Bob Kuiper, spokesman for Transforming Congregations, a. group of primarily Methodist churches that believe that homosexuality is an illness that needs to be treated, stated that while the 8 panelists were a majority which thought that conducting a homosexual ceremony was wrong and sinful he also hoped that because Creech won the decision, witch hunts to find ministers conducting such ceremonies would not occur.

The Reconciling Congregations, a program led by gay Methodists, encourages churches to welcome homosexuals. Of the 37,000 congregations throughout the world only 140 denomination's have adopted the program. During the inquiry Creech told the panelists that he would continue to officiate at unity ceremonies if asked. The Power of One.
