## A Message from the President

Dear Friends:

The Women's Central News Executive Board elections are coming up on March 10th at our monthly General Meeting, held at Insights, 333 W. Virginia, suite 106, Phoenix at 7pm.

The Executive Board President directs the organization through writing the monthly agenda; through fulfilling our bylaws as recorded with the Arizona Corporation Commission; through fulfilling the Reporters Team Leader position by recruiting and monitoring new writers for subject matter and writing skills and holding periodic meetings; through fulfilling the Sponsorship Team Leader position by recruiting new sponsors, and handling current sponsor calls/problems; and by recruiting and interacting with new volunteers. The Vice President takes charge of any and all tasks assigned staff cannot accomplish. The Secretary takes minutes at the monthly General Meeting, maintains a file of correspondence, picks up the printed newspapers from the printer and delivers them to the folding and stuffing site. The Treasurer keeps an exact accounting of all monetary issues affecting the organization, pays the organization's bills in a timely manner and stays abreast of IRS issues. Board Members fulfill the Distribution Team Leader position through

assigning distribution routes across the valley; through recruiting and managing staff for routes; through managing our secure mailing list by the addition of new members and deletion of expired members; through printing mailing labels and providing them at the monthly meeting where newspapers are folded and stuffed into envelopes; through delivering the envelopes to the Post Office for bulk mailing; and through managing all Postal issues including rate increases and meter payment.

All positions require at least one monthly meeting, possibly two, and solid interaction with other staff members. Tasks must be accomplished on a specific date in order to get the paper to distribution sites and in member's mailboxes by the first of each month. With the exception of Board positions, which are elected to a two-year term, all other positions require a commitment of one-year.

Should you wish to volunteer for any of these positions, you are invited to attend the General Meeting on March 10th. At the conclusion of normal business, members in good standing may become candidates and elections will then be held.

It is my pleasure to serve with so many outstanding women whose names are listed in our masthead on page three.

## Equality Begins At Home Arizona

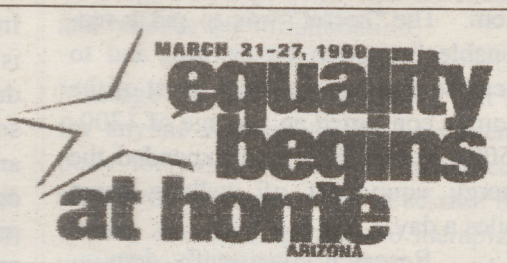

The first nationally organized, state by state political action to demand equality for gay, lesbian, bisexual and transgendered people will take place during the week of March 21-27, 1999.

The Equality Begins At Home (EBAH) campaign was launched by the National Gay and Lesbian Task Force to broaden the base of existing state organizations and direct focus on key state legislative issues. A major goal is to help counter recent anti-gay attacks by conservative groups.

1998 saw Senate Majority Leader Trent Lott compare homosexuality to sex addiction and kleptomania, and conservative Christian groups run national advertising campaigns purporting that homosexuals could change their lifestyle if only they wanted to badly enough.

In Arizona, the GLBT community has listened to hostile diatribes by elected officials. State Rep. Barbara Blewster compared being gay to "bestiality, human sacrifice and cannibalism." In one letter to a concerned citizen, Rep. Karen Johnson said "encouraging tolerance and acceptance" of homosexual activities will draw people into a "death style." Both of these representatives are in favor of bills that



would disallow domestic partner benefits within the state, and forbid schools to provide money and space for clubs supporting gay youth.

"The battleground for equality has moved to the states, and so have we," said Paula Ettelbrick, national coordinator for the EBAH campaign. "We are throwing down the gauntlet and demanding that state officials resist the right wing's efforts to deny us our basic rights as citizens."

The campaign in Arizona will focus attention on legislative goals such as repealing the states sodomy law and urging passage of the Arizona Employment Non-Discrimination Act. EBAH Arizona is coordinated by the Arizona Human Rights Fund.

"We won't sit still for punitive measures by representatives like Karen Johnson and Linda Blewster who are attempting to codify their morality into law," said ARHF board member Ron Passarelli. He added that letting elected officials know they have a gay and lesbian constituency is important.

## Measure to ban gay and lesbian school support groups

Arizona state Representative Linda Gray (R-Glendale) is trying to resurrect HB 2051, which calls for school districts to ban any student organization that would promote a "specific sexual orientation," "sexual activity of any kind," or "criminal activity." The bill, which had been previously introduced by Gray had been pulled because it would be in violation of the Equal Access Act, which requires schools to accept all student groups or risk losing federal funding. To avoid violating the Equal Access Act, the bill has been modified to require students to get written parental permission before joining a group; to require all student groups to promote sexual abstinence; and to prohibit the student groups from doing any advertising or promotions.

According to Amelia Craig Cramer of the Arizona Human Rights Fund, the new proposal would effectively prevent gay and lesbian students to join a support club if they are not "out" to their parents. Cramer adds that it could be a tough legal battle to establish the new proposal to be in violation of First Amendment rights, since on previous occasions the court has ruled that having "age appropriate restrictions" on free speech was legal.

## AIDS budget proposals

Two budget proposals are before the Arizona Legislature that would provide funding for the state's AIDS Drug Assistance Program (ADAP). The House Appropriations Committee is considering both of them.

Governor Jane Hull's budget calls for over \$1.7 million from the tobacco tax to be routed to ADAP. The Joint Legislative Budget Committee (JLBC) has proposed only \$1 million for ADAP, due to Arizona's increased AIDS funding from the federal Ryan White Care Act. The JLBC proposal would leave no provision for contingency funds in the case of increased expenses. Governor Hull will continue to push the Legislature to approve her budget's \$1.7 million allocation.

### Forgettable Fads

Here's a notably nifty suggestion for 1999: forget the fad diets. You know what they are, you've seen the infomercials, or the boxes in the drugstore, or the posters pushing them in the supplement stores. The bestseller lists are filled with diet books aimed at every conceivable group, although women are a primary focal point. How to pare pounds! Lose fat forever! And so on.

Somebody, somewhere, probably once told you that "if it sounds unbelievable, it probably is". The funny thing is, while we may take it to heart regarding Rolexes sold on the street corner, we seem to ignore it completely when it comes to weight loss. One of the most recent touts apple pectin as a highly effective "fat blaster", you'll lose 2 or more pounds of fat a week. Why, the fat will just melt off! Well, those of you with a country homemaker's heart know what apple pectin is: it is the stuff used to help jelly jel. How is this a fat blaster?

I digress. People faithfully follow diets like no-fat, high-protein, sugar busters, or eating right for their blood type, body type, color palette. Sure, you can lose weight on a diet,

but usually it is simply due to a decrease in caloric intake compared to calories used up in a day. It isn't due to the grapefruit, or the supplement, or fewer carbohydrates, or more protein, or eating the right diet for your blood antigens. It's usually because of eating less calories, or because a supplement may contain something like caffeine or ephedrine designed to speed up your metabolism (and your heart rate, and your sweating) to burn more calories at rest. Haven't you ever noticed on those commercials, in the small print, that the weight loss pills work only if you follow the enclosed diet/exercise program? Shouldn't this tell you something?

Hundreds of women who haven't used any such fad have managed to lose more than thirty pounds and have kept the weight off for an average of five years. The National Weight Control Registry has recorded thousands of responses from individuals who have lost and kept off weight, asking them to describe their methods and what worked and still works for them. The "secret" was to put a reasonable limitation on calories and to increase physical activity. Most of the women consumed an average of 1300-1500 calories daily and expended the energy equivalent of walking three miles a day.

Research consistently demonstrates that while you may adhere to a

"We want to have faces from their districts approach them and say, 'I'm here.' That we're deserving of more than second class citizenship."

The majority of debates and decisions about GLBT equality occur in state legislatures. EBAH Arizona provides everyone with the opportunity to have their voices be heard in unison with others across the country.

"This is an opportunity for people to be politically active when they never thought they could be," said Lyle Miller, executive director of The Community Center in Phoenix.

EBAH is intended to be an annual national grassroots organizing effort. The fifty state coordinated action was made possible by the Gill Foundation of Colorado through a grant to NGLTF.

"EBAH is not an end point but a beginning point," said Kerry Lobel, NGLTF executive director. "It is the organizing at the state level that will ultimately counter the hostility and gridlock we have come to know from out nation's capital."

The following is a description of EBAH Arizona events scheduled for the week of March 21-27, 1999:

•Before Monday, March 22: Mail a letter to each of your two Representatives and to your State Senator. If your don't know your district, call the Maricopa County Elections offices at 506-1511.

•Tuesday, March 23: Lobbying workshop at The Community Center, 24 W. Camelback Rd., Phoenix, at 6:00 p.m. The workshop will coordinate the next day's activities giving volunteers a chance to meet each other and discuss logistics.

•Wednesday, March 24: Attend the session of the House of Representatives as a group at 11:00 a.m. The purpose is to show the house the GLBT community's determination to protect and defend our rights and personal liberties as full and equal citizens. That afternoon, meetings will be scheduled with individual legislators and their constituents. A reception will be hosted by AHRF and the EBAH steering committee from 4:30 to 6:30 p.m. for legislators, state offi-

## Radio ads with the word "lesbian" taken off the air

Radio ads encouraging lesbians to have annual Pap smears have been pulled from airplay in Seattle, Washington. The ads, described by the Health Department as "tasteful and scientifically accurate", were sponsored with a \$20,000 grant by the Seattle-King County Health Department after a University of Washington study found that 30% of lesbians could have papillomavirus, which can be transmitted between women but can be readily

detected in Pap smears. The ads encouraged lesbians to have annual Pap smears, perform monthly breast exams, stop smoking, and exercise.

The spots aired on radio stations KMPS and KMTT. KMPS originally ran them in 65 slots, but canceled a number of them because every broadcast generated 10 - 20 complaints related to the word "lesbian." KMTT also canceled the ads due to complaints, but their listeners took offense to the term "Pap smears." A new ad has been substituted which refers to "annual exams" instead. It is yet to be determined whether or not the cancellations are a violation of the radio station's contractual obligation, and/or local human rights laws.

mia, but binge eating and yo-yo dieting, in which one eats enough in a month to justify three months, then goes on another fad diet to lose it again.

If your goal is to lose a few pounds this year, why not reconsider: aim to get healthier by being more active and by selecting healthier foods. This kind of goal makes you feel better about yourself: there's nothing "wrong" with your weight, you just need to make better choices. You are not hanging onto a number on the scale to determine your mood for the day, calling you "worthy" or "worthless". Instead, you can revel in the recognition you are giving your well-being, doing something for yourself and your health. You'll feel better, and you may be surprised to find that you may end up losing some pounds to boot, even though that's not the stated goal.

## Holistic Health Corner

Whether you're a weekend warrior, a professional athlete, very active, or physically use your body for work, you too can benefit from a sports massage. When you hear the words "sports massage" the first thing you think of is "it must be used by athletes." That's true, but sports massage is used for any kind of activity that requires you to use the same group of muscles over and over again. With such a broad definition, a lot of people can be considered athletes, maybe even you!

You probably know what muscle soreness of an athlete feels like if you ever enjoyed activities such as softball, volleyball, golfing, bowling, cycling, hiking, jogging, etc. Parents of small children certainly are athletes; they have to be to keep up with them! You can also be included in this category if your job involves manual labor such as painters, plumbers, electricians, postal employees, etc.

Sports massage is different from a regular massage. When your muscles become tight or tense from physical exertion, sports massage can reduce muscle spasm and pain. It flushes out toxins or lactic acid from muscles that may cause stiffness and soreness. It also restores the suppleness and elasticity of muscles. This helps to keep your muscles healthy and flexible, so sprains (stretched or torn ligaments) and strains (torn muscle tissue or tendons) are less likely to happen. A regular massage is more superficial; it may relax you and make you feel great but it doesn't target specific muscle groups or body parts that you've used during your sports game or any other strenuous activities. It can also rejuvenate your mind as well as your body.

For anyone who loves to be active or if your sport is your passion, an injury is more than just pain and frustration, it can be emotionally devastating. For serious or chronic conditions, sports massage can be used in conjunction with proper rest and medical care. It increases circulation of blood and lymph fluids, reduces swelling, increases the supply of nutrients needed for healing and reduces recovery time. Sports massage stimulates the release of endorphins (your body's natural pain killers), giving you pain relief. It can limit scar tissue formation in new injuries and reduce (or make more pliable) scar tissue around old injuries, giving you greater range of motion.

The professional athlete usually receives brief massages before, during and after an athletic event. Pre-event massage is invigorating and helps reduce anxiety. Mid-event massage is just a quick fix. Post-event massage is calming, relaxing, helps ease soreness and reduces any inflammation.

The "Maintenance Sports Massage" is the most effective. It's for anyone who physically uses their body for work play. It is scheduled after any physical activity. A session is usually one hour, giving the therapist time to work on those recurring problems or new ones. Think of the "Maintenance Sports Massage" as giving your car a regular tune-up. It keeps everything in good working order. It can locate small problems and keep them from becoming bigger or chronic problems. Sports massage helps identify tender areas before they develop into major injuries. This may save you from breakdown or injury in the future.

Sports massage is your "secret weapon." It helps you achieve your performance goals with minimal injury and pain. It is an adjunct to a fitness or sports program.

## Utah prohibits unmarried couples from adopting foster children

On January 22nd the board of Utah's Division of Child and Family Services (DCFS), after 2 hours of public testimony, voted 7 - 2 to prohibit unmarried couples, both heterosexual and same-gender, from adopting children in state foster care. According to Board Chair Scott Clark, gay and lesbian parents create "gender confusion" for children. He went onto say that unmarried households are twice as likely to experience domestic violence.

Advisory council to the Board opposed the action because it would decrease the number of available foster parents. DCFS was recently hit with a class action lawsuit for failure to find permanent placements for children in foster care. Also testifying against the policy was the Gay and Lesbian Community Center of Utah, a gay male couple who recently adopted a child, and a woman who was raised by lesbian co-parents. The American Civil Liberties Union of Utah, which also lobbied against the policy, charged that the policy is illegal, and Shannon Minter of the National Center for Lesbian Rights described the proposal as a "deliberate effort" by anti-gay groups, and said that she believed it can be challenged on 14th amendment grounds of due process and equal protection under the law.

Caseworkers will now have to verify that all adults in a prospective adoptive home and related by blood, adoption, or legal marriage.

## Heart to Heart

### ABUSE: AN EQUAL OPPORTUNITY ISSUE IN RELATIONSHIPS PART ONE

Question: How can couples deal with the pain of a partner's childhood sexual abuse and still remain connected and loving?

Being in a relationship offers you the greatest opportunities for healing on the planet. Being in a relationship where one or both partners have been abused is like doing "Relationship 401" instead of 101. It's an accelerated, advanced course!

Each of us brings to our relationship, a little red wagon filled with pain and possibility that must be processed and worked through together as partners in a conscious relationship. As we empty out our wagons and deal with the content of our childhood, we not only become more authentic and present to ourselves, we also become more present for our beloved.

I believe at least 70% of the women in this country and 40% of the men have experienced abuse as children. Therefore, it is not unlikely that many of you will deal with healing the pain of childhood abuse. This abuse can loom between you as a painful, separating force or it can become the fire in your connecting process. Many couples who work through this issue find they have individually cut through their ego's and much of the false pride to find the gold inside of each other and in their relationships.

In writing this column, and in honoring the life commitment of so many to healing abuse, it seems important to state that there is no way

even in a two part format, to begin to address the enormity of this issue. Abuse effects nearly every aspect of relationship and our sense of safety as we create relationships. We can, however, share some ideas and thoughts together that may move you toward finding that special book, reaching out for a specially trained therapist, or talking with an especially understanding friend about your own issues in order give more energy to yourself and your healing process.

In the thirty-seven essays contained in the book, *Healers on Healing* by Carlson and Shield, **there is one common denominator** spoken of by every well known contributor. **It is love.** Inside the complex nature of healing there is this one truth and you will find yourself required to return to it again and again as you face this issue. When you feel rejected, when you feel small, when you feel vulnerable, when you feel confused, when you feel ashamed, when you feel frustrated, when you feel outraged, whether you are the survivor or the partner- there is but one question that can get you back on track toward healing. It is, "What would love do?" When you are doing what love would do, you are into healing.

It is not unusual to lead in the romantic process with the physical and then later bring the mind, heart and spirit to the party. That's why many couples find themselves dealing with these issues once they are well into their relationships. When we have finally reached a place of feeling safe, having connected more deeply, it is then that these issues emerge because we are feeling safe enough to deal with them. The fact that childhood sexual abuse comes up as an issue, instead of remaining suppressed, may be a very good indication your relationship is

working. Bitter sweet, but true.

**The first step in your healing process is learning not to take everything personally.** When survivors, male or female, are experiencing childhood memories that make them recoil or push away from the process of being sexual, **it is not about you, partners!**

When partners begin to feel rejected or as if they are "not doing it right, well enough, etc," **it is not about you, survivors!** Whatever response you may individually have to what is taking place in the sexual process comes directly from your own little red wagon of childhood experience, and as partners you don't have to be responsible or take the blame for each other's responses. I know that sounds confusing but let's look closer. If you push away from me because we have triggered a childhood memory of your abuse, I have lots of ways of responding to that. I can feel badly for you and hold you until the feelings pass. I can get angry that you are having the painful feelings. I can get angry with myself and stomp into the other room feeling dejected. I can move into "poor me" and choose to feel as if I am the victim. The choice that I make is about me and my life experiences, it's **not about you!** And furthermore, the choices that I make reflect what my work is in this process.

Everything in relationship is 50% - 50%. As a partner of a survivor it is important not to fall into the trap of thinking that the person who got abused is the only one who must heal and change! Challenges and issues in the relationship are not just the result of the survivor's abuse. On some level,

conscious or unconscious, you voted to be with a survivor! Why did you do that? What do you think you will learn about yourself from being in a relationship with these challenges? Your part and process in the healing is equally as important as that of your partner who is the survivor.

**The second step along the path of healing is making a commitment to communication.** Take time to talk about how each of you feels about dealing with this issue. As a partner and as a survivor, what are your fears, your hopes, what tools do you have that could be supportive? What tools do you need to cultivate or research? What support systems do you each individually have that you can turn to? What support systems do you need to locate? What feels frightening? What could make each of you feel safer?

Abuse brings equal opportunities for learning and growing! When you discover that and embrace it you will not feel nearly so separated, isolated or alone. The journey and the gifts that come from it belong to both of you. Watch for exercises in our next segment that will focus on how you and your partner can remain connected as you face the past together.

## Website memorializes trans dead

SAN FRANCISCO -- February 8, 1999 -- All Rita Hester wanted to do was live her life just like any other woman.

When Hester, a transgendered woman who lived in Boston, was found murdered by multiple stab wounds in her own apartment late last November, this was more than Gwen Smith, another woman living across the country, could bear. Ms. Smith, a professional Web designer living in the San Francisco Bay Area, did not want to do a project relating to violence and prejudice against transgendered individuals. She had to.

Ms. Smith's desire for justice led to her creation of the Remembering Our Dead website, a memorial to individuals killed for the simple "crime" of trying to be oneself. For

example, 9-year-old Steven Wilson, taunted for playing with "girl's toys," who was raped and drowned by a neighbor child. Or Tyra Hunter, taunted with racial and transphobic slurs and neglected by emergency personnel, who died from inadequate medical care. Or Debra Forte, who suffered multiple six-inch stab wounds to the chest, any one of which would have been sufficient to kill her. As Ms. Smith notes, "When one looks at how many transpeople are murdered, and considers how much complacency there is towards these murders, one realizes that something needs to be done."

Currently, the stories on the website date back as early as 1969, and as recent as February 6th, 1999. With a reported 60% of transgender individuals having been the victim of a violent assault, it is doubtful that this site will stop growing anytime soon. Hopefully, through public education and awareness, this issue will receive the attention it deserves, along with more well-publicized accounts such as

## Gay Student Club Will Save Lives

The struggle for dignity as a human being begins with recognizing who you are and accepting yourself. I was reminded of that recently when I met two young people who are trying to retain their dignity in the face of bigotry.

Jesse and Melanie are two students from a high school in the East Valley who are embroiled in a controversy surrounding a "club" they helped to establish in their school. Jesse asked that I not mention the name of the high school or the actual name of their club. I'll call them "the alliance". The club is an alliance of gay and straight students who want to come together to provide a safe and supportive space for gay, lesbian, and questioning youth.

Precisely the kind of club that the state legislature is considering banning with HB2051, which would prohibit the use of school monies, property, resources and employees for any student club that "encourages criminal or delinquent conduct, promotes sexual conduct or sexual orientation or that contradicts the states abstinence requirements" in dealing with public schools.

Jesse has a problem with the bill. "The Equal Access Act specifically prohibits banning clubs based on their content," he said. "The right to freedom of assembly and freedom of speech is guaranteed to all U.S. citizens, homosexual or heterosexual, under 18 or over 18."

Jesse said the visibility of an alliance of this type is important to be able to reach students who may be feeling the pain and isolation of growing up gay. "Our club will save lives," he said.

Studies consistently show that gay and lesbian youth are more likely than heterosexual youth to attempt suicide. The U.S. Department of Health and Human Services reports that gay and lesbian youth account for up to 30 percent of all teens who commit suicide. They do so because they can not face the stigma of being a homosexual in this society.

As I sat listening to Jesse's gentle and convincing voice I was taken aback by some of the things he said. I had assumed that so much had changed since I was a teenager some

decade plus ago. I'd forgotten that dark corner of isolation. Of not having someone to talk with that you could trust to understand. That darkness still exists for gay youth. Having a place to go where you can be yourself and feel valued and safe is an important part of lighting the way.

To Melanie, the alliance they've formed is that place.

"Without it you feel so alone. The emotional pain can be so extreme," she said. "We need to have the resources to help other people."

"The pain and self-loathing; the misconceptions you have about yourself are horrible," said Jesse, who admitted to himself in the ninth grade he was gay. "I thought that all gay people had AIDS and were child molesters. I remember that pain."

Both Jesse and Melanie said they have supportive, loving mothers to whom they are "out". Imagine the isolation of the young boy or girl growing up in a family where prejudice against "queers, dykes and fags" is an accepted part of everyday conversation. They need a place to find support and understanding.

The alliance faced some challenges.

"Our principle cares about his students," said Jesse. "The administration was sometimes unfair but out of genuine fear for us." It took many months for the administration to finally approve the paperwork for the alliance to meet at school, and that came only after Jesse threatened to sue the school under equal access laws. He then had to face an unsympathetic student council which eventually voted approval by a small margin.

The club has officially been in existence for two weeks. It meets twice a week, has more than 20 members and two teacher sponsors. There are great challenges ahead for the alliance. Parents who are upset that such a group even exists in their children's school. Oh yeah, and then there's the state legislature.

Arizona is one of three states with bills pending that are unfavorable to gay, lesbian, bisexual and transgendered students.

I know of one school that is lucky to have people like Jesse and his friends who are willing to take a stand for their rights. Who will provide a place to rejoice in their freedom to express and be themselves. Who will be there to heal the wounds of intolerance with the salve of acceptance.

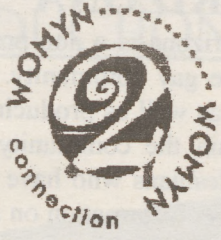

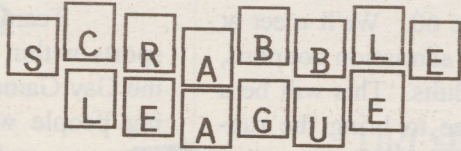

**Spring Equinox**

Spring Equinox is on Saturday, March 20 this year. Just as at Fall Equinox, the day and the night are of equal length. However, since it is spring, we are in the waxing part of the year's cycle. From this point forward, the days grow longer and the nights shorter - the year is waxing into light, warmth and fertility.

At Spring Equinox, Persephone returns from the underworld to her mother Demeter, and all the earth blooms with rejoicing, notes Di-

ane Stein in her book *Casting the Circle, A Women's Book of Ritual*. The Goddess is a laughing child, inquisitive, and getting into everything. The growing Goddess plays with abandon, running wild through the fields and cities.

Correspondingly, Spring Equinox rituals are a time for reclaiming childhood and the child-within. Women go within to discover their child selves and heal the hurts that might still be there.

Eggs are the Sabbat's primary symbol, for fertility and fecundity and also for the great cosmic egg of the

Goddess, from which the universe was hatched. Other symbols are green growing things and children's foods, says Stein. The colors are pastels and the theme is childhood innocence. Use a rainbow of bright colors for this Sabbat, and a playful tone and mood, advises Stein.

Spring Equinox is a solar Sabbat, which means that its date changes with the solar year. So although it is on March 20 this year, it could be on any date in the range March 20-23 in other years.

According to Stein, Goddesses for spring are Mother Goddesses, of-

ten shown with children from many cultures. Among them are: Isis (Egypt), Oddudua and Oshun (Africa), Hina (Polynesia), Demeter and Gaia (Greece), Parvati (India), Copper Woman (Native America), Kwan Yin (China), Chalchihuitique (South America), Mary (Christian), Lilith Hebrew), Guadalupe (Mexico) and Eostre (Saxon) or Astarte/Ishtar/Esther (Semitic), from which the Sabbat gets its other name of Oestre. Easter and Passover are both derived from this Sabbat, says Stein.

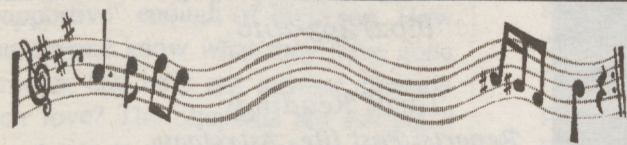

## Review of "Higher Ground" by Barbra Streisand

Barbra Streisand's musical offering *Higher Ground* is aptly named. The CD is a compilation of inspirational songs - 12 in all. Barbra uses her wide-ranging, soaring voice to sing about love lifting you higher, hope for peace in the world, lessons

learned in life and love of God.

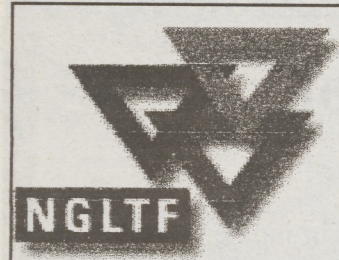
The most familiar song on the CD is "Tell Him", Barbra's top 40 duet with Celine Dion. You can just change every "him" to "her" and sing right along. Another song in the love vein is the title track "Higher Ground" in which Barbra asks her love to "take my hand and lift me higher. Be my love and my desire . . . take my heart to higher ground." You won't need to change the pronouns on this one, as Barbra doesn't use any.

Most of the songs on the CD are not about romantic love, however. They fall into a more general inspirational category. In one of my favorites, Barbra sings of all the hearts beating in the world "At the Same Time". This song reminds us of all we have in common, and tells us it's time for us to be a family and protect our precious planet. Other songs in this vein include "Leading with Your Heart"

which tells us that feelings are wise and that "leading with your heart, you will find the way", a song that tells us we are all joined in a "Circle" of life and "Lessons to be Learned" in which Barbra tells us, "Like the seasons, there are reasons for the path we take, there are no mistakes, only lessons to be learned."

Barbra has done an excellent job on this musical offering. Her voice is as magnificent as ever. The words and music are well-matched, with instruments ranging from soothing piano to full orchestra, as appropriate. And she has carefully chosen songs that fit in with the theme of "higher ground." ## Wyoming legislature kills hate crimes bills

WASHINGTON, DC--The Wyoming legislature today killed all prospects of enacting the state's first-ever hate crimes law. Wyoming was the scene of the brutal and highly publicized murder of Matthew Shepard last October. The Wyoming legislature is still considering a measure to establish a governor's bias crimes task force. Activists in Wyoming oppose this measure, viewing it as an attempt to avoid substantive action on hate crimes.

"If not now, when?" stated National Gay and Lesbian Task Force executive director Kerry Lobel. "These statutes are not a panacea, but they are a crucial component in the battle to eradicate hate crimes. We are extremely disappointed that legislators in Wyoming refused an opportunity to take real leadership on this issue. Our community will continue to press for an enforceable hate crimes law in Wyoming, and we will not settle for legislative smoke and mirrors," added Lobel.

The Wyoming Senate Judiciary Committee voted down two bills today. One bill (SF 84) would have established enhanced penalties for bias-motivated crimes committed because of the victim's race, religion, color, disability, sexual orientation, national origin or ancestry. Another

measure (SF 91) would have established enhanced penalties for bias-motivated crimes committed because of an individual's "membership in a group." Last week the full House voted against a bill similar to SF 84.

According to the National Gay and Lesbian Task Force, hate crime bills have been introduced in at least fourteen states this year. In nine states (CO, ID, MT, MS, MO, NY, OK, VA, WY) bills have been introduced to add sexual orientation to existing hate crimes statutes. In addition to Wyoming, the Idaho and Montana bills were defeated. In three states (IN, NM, SC) the bills would establish first-time hate crimes laws in those states. In Texas, a measure has been proposed to strengthen the state's existing statute by enumerating groups that would be covered under the law. The California legislature is considering a bill to equalize penalties for anti-gay hate crimes with penalties for other types of bias crimes. Other states likely to see hate crimes legislation this year include Michigan and Hawaii.

"This is a tragedy for the citizens of the Equality State. How many more people will have to be attacked before the legislature will take a stand and say no to violence and hate?" stated Wende Barker, coordinator for the Wyoming Bias Crimes Task Force.

## Winner Takes All

If you're a tennis fan, then you probably already know about French women's tennis star Amelie Mauresmo. After her Australian Open victory over Lindsay Davenport, it's a lot more likely you know her, tennis fan or no. Mauresmo, 19, attended the Open with her girlfriend, and came out in France before stunning both spectators and commentators alike not only with her amazing play, but her openness about her sexual orientation. Sadly, Both Hingis and Davenport chose to comment about Mauresmo during the Open, Hingis stating "She's here with her girlfriend. She's half a man," and Davenport saying "I thought I was playing a guy." Davenport quickly and genuinely apologized. Hingis also said "sorry" to Mauresmo after their final match, but then backpedaled, telling Sports Illustrated "[I] wasn't regretting" what she had said. "Everyone makes her own choices," she continued, "but they are hugging and kissing all the time, and I'm just 'OK, there's a limit.'"

With this said, the coverage of Mauresmo's victory and previous coming out (according to French LGBT groups, she has been active in her home country) has been quite good, considering the coverage seen during Martina Navratilova's coming out, and Billie Jean King's "galimony" suit. Among the outstanding pieces:

The New York Times wrote a long piece in the Sunday Sports section, exploring Mauresmo's coming out, and the controversy generated by Hingis' and Davenport's comments. The piece, by Christopher Clarey was an excellent illustration of how talking about sexual orientation doesn't have to become a referendum on the lesbian, gay, bisexual and transgender community. In addition, after Hingis'

comments to Sports Illustrated, NYT ran an interview with Billie Jean King, women's tennis legend, who discussed Mauresmo's coming out, and said that Hingis needs to learn from her older counterparts, including her mentor Chris Evert, about these issues. Coming from an experienced source who has, in her own words, "lived this", the article was a perfect counterpart to previous sensationalist surrounding the topic of lesbians in

sports.

New York Daily News writer Luke Cyphers, in his article "Tennis Warrior", talks about how Mauresmo, "the hottest tennis star [in France] since Yannick Noah," may well show that being out isn't a death sentence for the lucrative endorsements that many sports stars sign. He examines the growing numbers of fans flocking to Web sites, and conjectures that the U.S. Open may become a mini Dinah Shore weekend, a popular lesbian destination which occurs during a golf tournament.

The aforementioned Sports Illustrated article, which talked about Mauresmo's orientation, but as any good sports magazine should, spent a lot of space on her game.





## Matthew Shepard: His Parents Speak

Judy and Dennis Shepard, parents of Matthew Shepard, recently spoke for the first time in the press about their son, his murder, and the aftermath. They appeared on Dateline NBC on Friday, January 29, in an interview with Katie Couric. The Shepards, dignified and soft-spoken, talked about their son with love and sorrow in a deeply moving and respectful way. Unfortunately, the story itself was marred by poor writing, talking about how Laramie was no place "to live a gay lifestyle," and how Matthew, while at the University of Wyoming, was not one "to flaunt his sexuality." But this did not detract from the honest, straightforward way in which the Shepards spoke about their son.

The March issue of Vanity Fair magazine features a long piece on Matthew Shepard and the events and people surrounding his murder. Entitled "The Crucifixion of Matthew Shepard," writer Melanie Thernstrom talks to Shepard's parents, people who were Matthew's friends, those who were friends with his alleged assailants, and the residents of Laramie. Thernstrom has done an enormous amount of personal research, and it is obvious she spent a significant amount of time in the place where Matthew lived and died. There are choices that many may argue with: Thernstrom's discussion of Matthew's depression, his health and HIV status; and there are those who would say that these are as relevant as the facts of his murder, making him human and whole instead of a one-dimensional martyr.

GLAAD learned through a spokesperson that the Shepards have been upset at the response to their appearance on Dateline NBC, when they learned that some members of the lesbian, gay, bisexual and transgender community felt that they weren't "supportive" enough of their son. How can anyone know what they have gone through, and how can anyone question their love? The Shepards are starting a foundation to do work in the area of human rights: one of these areas will indeed be for lesbian and gay rights. Their willingness to speak about Matthew, and to begin to try and further the work he had sought to do in the future is nothing but supportive. We can only hope that the community can continue to do that work as well, in the many ways and venues there are to do it in.

## Teletubbies Hubabaloo: Children's Television "Gay Conspiracy"



Tinky Winky

One might have thought that the impeachment trial had ended with all the media scrambling that took place after the Associated Press reported that Jerry Falwell's National Liberty Journal had published "Parents Alert: Tinky Winky Comes Out of the Closet," alleging that the Teletubby Tinky Winky is intentionally being presented as a gay role model. Outlets local and national scrambled to cover the story and get reaction from LGBT organizations. The "Alert" included such brazenly obvious "gay clues" as:

- "He is purple - the gay-pride color"
- "his antenna is shaped like a triangle - the gay-pride symbol"
- Tinky Winky, who is played by a male, carries a red bag described by Falwell as a "purse"
- In a Washington Post "editorial" (see below), Ellen DeGeneres is pictured alongside Tinky Winky on a list of "who's in, who's out." (Note: Tinky's "In" not "Out.")

Falwell referring to a pop culture "hot list" as an editorial is questionable, if not downright wrong, but then other sources repeat the mistake, not checking the article in question.

Among the coverage of Tinky Winky's outing, some highlights were:

- ABCNews.com's Interactive Tinky Winky, that let you click on an area of the Teletubby's picture to find out what Falwell objected to about it.
- The Washington Post's Hanna Rosin opening her column about the controversy with "Maybe it was the time Tinky Winky gave that 'big hug' to Dipsy. Or maybe it was the time he 'fell on his back' if you catch the drift." She also gets a great quote from author Andrew Sullivan involving Bugs Bunny, Elmer Fudd, Pinocchio, Boys' Town and Batman and Robin.
- MSNBC.com had an unfortunately titled story, "Falwell endorses gay Teletubby story" (as if the story didn't originate with him), and a poll asking "Do you think Tinky Winky was created to promote the homosexual lifestyle?" Fox News, titled their coverage "Falwell: The Antichrist May Not Be Jewish, But The Purple Teletubby is Definitely Gay," referring to Falwell's apology last

week for a speech in which he stated that the Antichrist was alive, disabled, in his 30s and Jewish.

We invite readers to respond in any way they see fit to Rev. Falwell's "outing," remembering of course that it should entirely be Tinky Winky's choice as to if and when he will come out. Look for more breaking news about the controversy on most major news outlets, and minute-by-minute updates on The Cartoon Channel (just kidding.)

## "My computer outed me!": That's one powerful chip!

Intel has announced that each of their new Pentium III computer chips, would have a unique serial number, which would be broadcast to help e-commerce (i.e. Web shopping) sites verify the user's identity, and helping prevent credit card fraud. Unfortunately, Intel seemed to have forgotten about the needs of those who use the Web and Internet specifically because of the anonymity of the medium.

Intel said that the "feature" would be turned on when a consumer received the computer containing the chip from the factory. The user could then turn the feature off for each individual user session, but upon restart, would then reinstate the serial number, making it available to other computers.

Upon learning of the release, electronic privacy groups EPIC (Electronic Privacy Information Center) and Junkbusters called for a boycott of Intel. GLAAD, John Aravosis of Wired Strategies, and Carl Pritzkat of Media-polis, issued a joint release calling for Intel to voluntarily remove the "feature," out of concern for the lesbian, gay, bisexual and transgender community.

Most often breaches of privacy online are due to human action. What Intel has done is make the threat to users' privacy much greater, as those who may not be technologically adept may not understand how to turn the serial number off, or may simply forget. This may track the user across the Net, broadcasting their identity to sites and helping them collect information on their visitors. Results could be disastrous: employees may be fired for contacting a LGBT informational site in a state with no job protection legislation; young people may be confronted about their sexual orientation long before they're willing (or able) to discuss it with parents or educators; identities may be stolen and used against the person.

Intel has announced that it will release the chip with the serial number turned off, however, they have not yet agreed to disable the feature completely. While this is a positive response, the full removal of the serial number is essential to preserving the personal privacy of members of the GLBT community, and others who don't want their computers to be tracked.

Please contact Intel and tell them that the Net is too important to our community to be lost to the threat of unwanted disclosure.

## Attorney General Bill Lockyer removes California from Hawaiian same sex marriage brief

In April 1997 Attorney General Dan Lungren joined nine other attorney generals in filing a friend of the court brief with the Hawaii' Supreme Court opposing any recognition of same sex marriage by the State of Hawaii'.

On February 12, 1999 Attorney General Lockyer removed California from the lawsuit.

Mr. Lungren did this on his own in the name of the People yet the People through their elected representative in the Legislature had taken no position on the matter of same sex marriages.

Twice, Senator, then Assembly member, Pete Knight introduced a bill dubbed California DOMA - Defense of Marriage Act - very similar to Federal legislation passed by an eager Congress under pressure from the Radical Religious Right which bars recognition of same sex marriages by the Federal government.

The Knight legislation which would not recognize same sex mar-

riages licensed in other states passed the Assembly and was amended in the Senate to recognize benefits for domestic partners but not marriage.

Knight didn't like the amendments and withdrew the bills. He is now subjecting the state to an initiative approved for the March, 2000 ballot because he was not willing to grant same sex couple any kind of recognition.

The amicus brief filed in Hawaii by Lungren et als, among other things said: "Legalizing same-sex marriage would be extremely divisive, impair interjurisdictional recognition of Hawaii marriages and related legal benefits, and severely strain Hawaii's relations with the other forty-nine states and the federal government. The State of Hawaii has a compelling interest in avoiding such consequences."

On January 11, 1999, Jerry Sloan of Project Tocsin contacted Attorney General Lockyer's office and asked him remove California's name from the brief and also contacted gay press and others asking them to contact the AG.

Upon hearing of Lockyer's action Sloan said, "It is fitting Attorney General Lockyer made his notification on Lincoln's birthday, a day when we celebrate freedom."

## 1998 exit polls show diverse picture of identified gay, lesbian, & bisexual electorate

WASHINGTON -- Voters willing to identify themselves as gay, lesbian or bisexual, representing 4 percent of the electorate, are one of the most diverse constituencies in America, according to an analysis of Voter News Service polling data released today. The poll, conducted on Election Day 1998, showed that gay, lesbian and bisexual voters are more positive about the direction of the nation and the future. The size of the G/L/B vote in 1998 was similar to the 1996 Voter News Service exit poll, which put the G/L/B vote at 5 percent.

"This poll underscores the diversity of the gay, lesbian and bisexual vote and establishes it as a key voting bloc," said HRC Communications Director David M. Smith. "Those seeking office from both parties should take notice, as this constituency becomes more and more identifiable and politically potent."

The poll revealed major demographic differences between those willing to identify as gay, lesbian or bisexual and the whole national electorate. More G/L/B voters are non-white, 32 percent vs. 18 percent, and the G/L/B constituency is younger, 88 percent under age sixty compared to 72 percent under age 60 among voters overall. The G/L/B vote consists of more men, 59 percent male among G/L/B voters, compared to 49 percent male among all voters. Gay, lesbian and bisexual voters also had lower family income, with 66 percent under \$50,000 vs. 52 percent for the entire electorate.

According to the poll, gay, lesbian and bisexual voters are more optimistic about the direction of the country with 68 percent saying things in the country are generally going in the right direction, compared to 59 percent of all voters.

Nationally, Democratic House candidates greatly benefited from the G/L/B electorate, receiving 65 percent of the vote, compared to only 32 percent for the Republicans. The Democratic leanings of G/L/B voters was even more pronounced in California where they chose Democratic gubernatorial candidate Gray Davis over Republican Dan Lungren -- 73 percent to 19 percent. In the California Senate race, G/L/B voters gave Democratic incumbent Barbara Boxer a significant boost over Republican Matt Fong, 68 percent to 28 percent (California was the only state where data was available).

Politically, 49 percent of gay, lesbian or bisexual voters consider themselves to be liberal, while 37 percent of G/L/B voters say they are moderate and 14 percent consider themselves conservative. In contrast, only 19 percent of voters overall consider themselves liberal, 31 percent conservative and 50 percent moderate.

G/L/B voters are also much more active on the internet. 60 percent claim regular internet usage vs. 40 percent of voters overall.

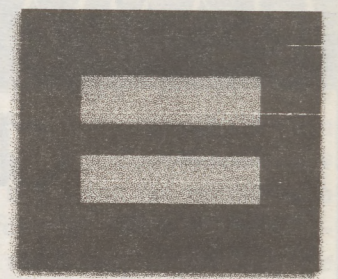
"Because of intense societal anti-gay bias, many people are still reluctant to identify themselves as gay, lesbian or bisexual," Smith said. "As result, this poll cannot be interpreted as a definitive look at the size or tenor of the gay vote, but it does offer an emerging picture of this often overlooked constituency."

The Voter News Service exit poll is conducted for ABC, CBS, NBC, CNN, Fox and the Associated Press. The Human Rights Campaign purchased the data from Voter News Service.

adult content," said PFAWF President Carole Shields. "This is an obvious attempt to stigmatize an entire group of Americans."

The Christian Action Network announced that it would launch a grassroots campaign to have its "HC" warning label placed on all programming with "homosexual content." It claimed in a press release that "more than two dozen homosexual characters" are portrayed weekly on network television alone (presumably, this figure includes Tinky Winky the Teletubby, who was "outed" without his permission last week by the Rev. Jerry Falwell).

"The sad fact that groups on the fringe of American politics would seek to target gay and lesbian TV characters in this manner points out how far we still have to go to achieve the American dream of justice," Shields said. "With this proposed content rating, the Christian Action Network seeks to put a slanderous smear on gay and lesbian Americans."

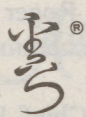

## NOW endorses Millennium March

Following lengthy discussions over the last four months, the Board of Directors of the National Organization for Women (NOW) voted to endorse the Millennium March for Equality, based on assurances by March organizers that a number of NOW's concerns would be met.



"We are facing serious right-wing attacks on lesbian and gay civil rights. We must start the new century with unprecedented strength. To do so, we need a unified, progressive movement where everyone has a place at the table," said NOW President Patricia Ireland. "NOW's participation in the Millennium March depends on the inclusion of feminist concerns in the March agenda and people who represent the wide diversity of the Lesbian, Gay, Bisexual and Transgender (LGBT) community in the organizing process."

The resolution passed by NOW's Board anticipates that the March agenda will address discrimination based on not only sexual orientation, but also sex, race, class, age and disability. NOW received assurances that the right to privacy and to control one's own body, implicit in the March agenda, would include the right to abortion and reproductive health care. NOW's endorsement is also contingent on a commitment that with its expansion, the Millennium March On Washington's (MMOW) board will represent the diversity of the LGBT community, including open lesbians of all races, colors, abilities, classes and ages. Finally, NOW's resolution recognizes the importance of the MMOW's board's taking steps to reconcile the differences that have arisen within the LGBT community over the March.

Organizing for the Millennium March got off to a rough start when key-players in the LGBT movement challenged the manner in which the march was called, and questioned what role people of color and issues of race and class would play in the event and the organizing process. While many individuals and organizations who fight racism have signed-on to the march, the controversy still exists.

"By signaling our willingness to participate in the Millennium March, we hope we can help facilitate a resolution to the existing problems. NOW wants to be part of the solution," Ireland said. "Now is the time to close ranks and fight our enemies -- not each other."

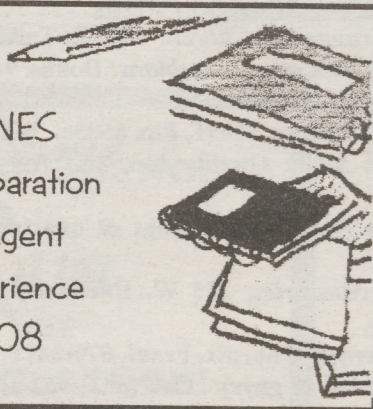
