## Spunk Talk

**Tough breaks & stiff  
hype pointed this  
rocker back to  
what makes him  
happy — his music**

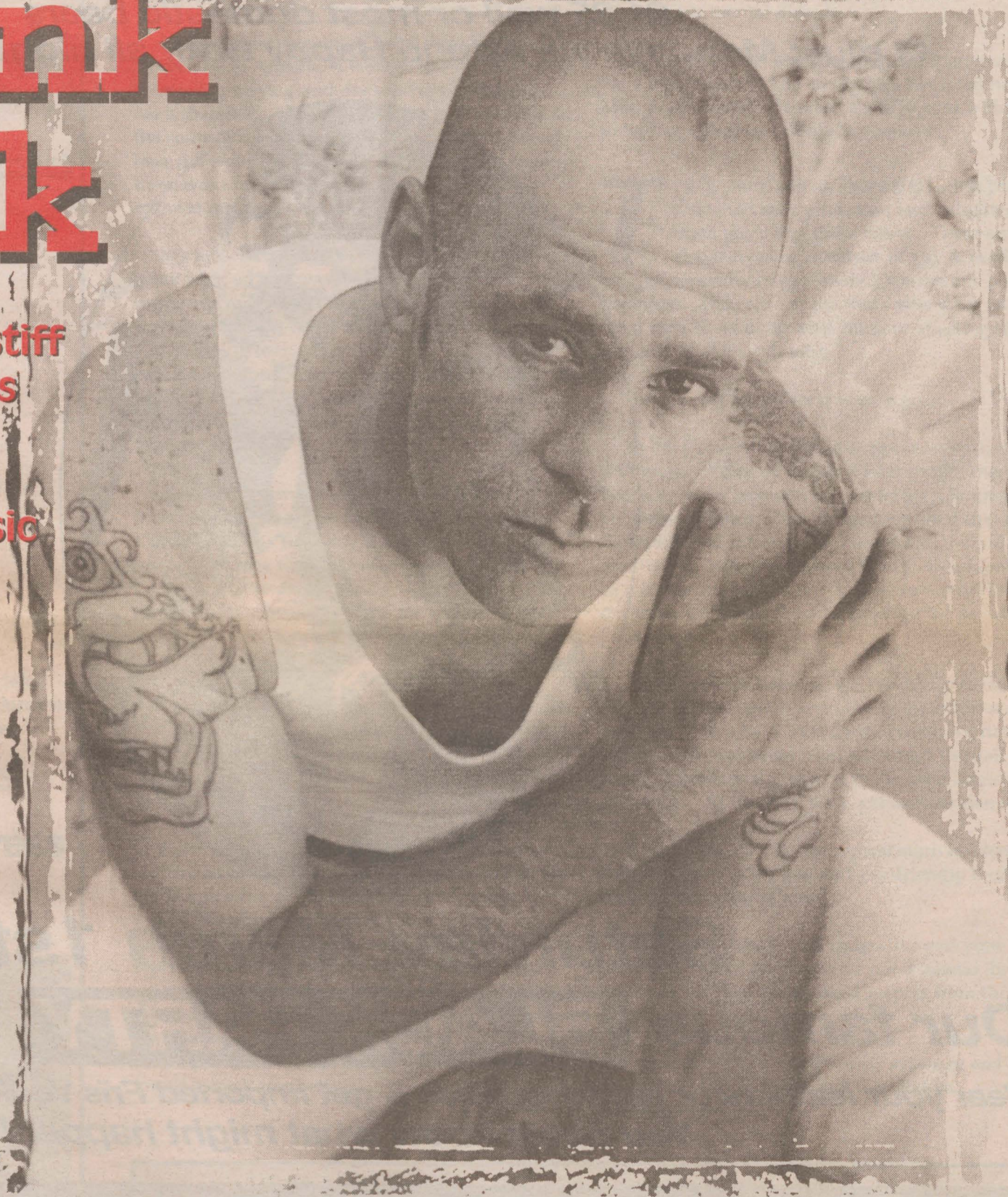
A friend of mine sometimes refers to "getting high" as tweaking. As in, "that guy was definitely tweaking on something." I remembered that phrase recently, after an intense chat with this issue's coverman. Brian Grillo is the lead singer and founder of the LA-based rock band, Extra Fancy. *Wow*, I thought, *this guy is definitely tweaking on something*. And he doesn't even do drugs.

Instead, Grillo achieves his "high" discussing his art, by writing songs, and in the hard-core performances he puts on with his band. He's a true showman, as known for stripping off his shirt and rocking-out while beating a 50-gallon oil drum as for his big, rock & roll vocals.

Grillo has the face of a movie star and the thighs of an Adonis. Tattoos, piercings, a shaved head and a fierce attitude are not some put-upon, music-industry gimmick to this man; at 35, he's been living his life and doing music his own way for a long time.

But don't even try to shape the story of Extra Fancy into the story of the studly, in-your-face gayboy who's fronting a punk band. In Grillo's eyes, that sorry whine has been covered to death. *That* was last year's news. He, his manager and his bandmates are over it.

He doesn't need LA music critics to tell him he's good at what he does (though plenty do) — he just knows it. "What can I say?" he asks, "We rock." D.A. Foster, Michael Hately and Derek O'Brien make up the other three quarters of the band, and would

be very satisfied if the mainstream press and the music industry could manage to focus more on their music and less on their image.

The sound they produce is described by the Extra Fancy guys themselves as sexy, surf-core "spunk" rock. It may be hard to define, but that's all right with them. The boys in this band have made it clear that they are not fans of being labeled, anyway.

Last year, Extra Fancy suffered its greatest setback when it was shown the door by its record company shortly after producing one, very well-received album (*Sinnerman*, on Atlantic). Despite accolades for the

music and— especially — for Grillo's powerful lyrics, no single was released. No slick video was produced and lobbied into rotation, no tour promoted, virtually nothing was done on the label's end to push this band.

1997, says Grillo, is going to be a great year for Extra Fancy. He's excited about the new material the band is working on. Percussionist/drummer O'Brien has recently added a conga sound to the mix.

**T**he highlight of our interview (for me, anyway) came when Grillo played me a tape of something they had just written. The song fea-

tures the congas, and a tribal rhythm. It sounds very different from anything on *Sinnerman*. I asked Grillo if he wanted my initial, gut reaction...

**HeatStroke:** *I'm not incredibly familiar with your music. You want me to tell you how that new song strikes me anyway, right off the top of my head?*

Brian Grillo: Of course!

**HS:** *It makes me horny. That sounds like music to... umm...*

**BG:** Music to fuck by? I know! Isn't it hot? We have about six songs in the works, with that sound. I'm

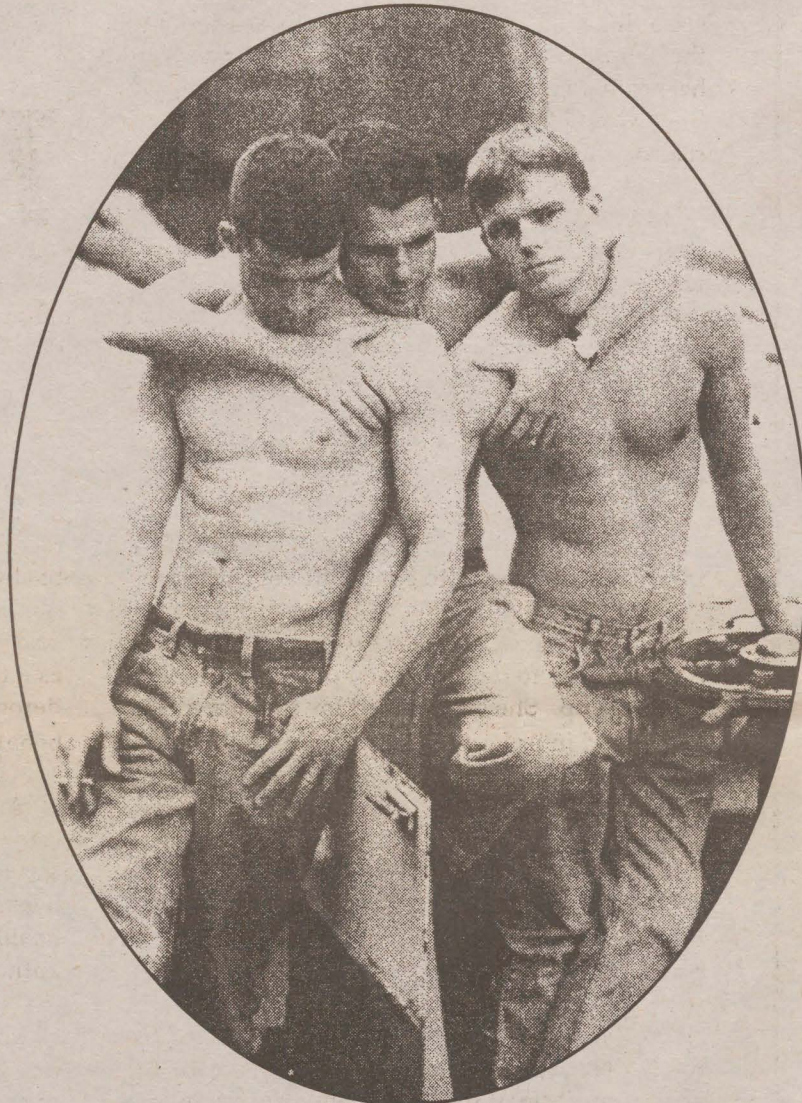

# Horowitz: *Mental health care for gays & lesbians is getting better — slowly*

**A** large part of my workday is spent evaluating the qualifications and skills of mental health professionals. I run an assistance program that requires me to maintain a database of mental health care providers, to whom I feel comfortable referring clients. Almost exclusively, my clients are lawyers.

Lawyers present unique circumstance, and often have mental health issues requiring special attention. So do gays & lesbians. I have had negative experiences with mental health counselors on more than one occasion — encounters that jolted my senses.

I first sought help when I was a student at The University of Arizona. I went to the student health counseling service, and made an appointment to see a therapist. At our first and only session, I told the counselor I thought I might be gay. She would hear none of it. She cut me off midstream, saying there was nothing she could do for me. She referred me to a nutritionist!

My next venture in counseling came several years later, when I was engaged to be married to a woman. I explained the details of my life — including the fact that I was a successful attorney and planning to marry in a few months — to the psychologist provided via my managed health-care plan. She said I appeared to be mentally healthy, and asked what the problem was. I told her that I was gay.

She said that we had a total of six sessions — including that one — to deal with the situation. During those six sessions, I managed to get up enough courage to break the engagement, but we hadn't begun to deal with any other issues. Our time was up. She encouraged me to place a "personals" ad in order to meet someone, and sent me on my way.

These incidents are part of my own experience. But they are not unique. Nor do they come close to the horror stories many other gays & lesbians tell about bad experiences with the mental health profession.

According to a national survey, conducted by the University of Washington and presented at the annual meeting of the American Association for the Advancement of Science, 1 in 4 lesbians and/or gay men who saw mental health care providers reported receiving poor or inappropriate treatment. Also frightening is that the dissatisfaction rate for gays & lesbians is forty percent higher than the dissatisfaction rate for involuntary mental health patients — those people who are, literally, forced to seek counseling.

After the disappointment of my own initial counseling experiences, I was reluctant to seek professional mental health care. I turned instead to the gay & lesbian community for support and fellowship. The community resources available proved to be valuable — yet they could not substitute for appropriate, professional assistance.

Our issues are real. They can be complicated and serious. Support from friends and community is good, but sometimes just doesn't cut it. I have a great deal of hope for the mental health profession. Change takes place slowly, but surely. At least homosexuality no longer finds itself on the list of diagnosable mental disorders.

My own more recent therapeutic experiences have been superb. The counselors I've used have been professional, educated about — and willing to look at — sexual orientation issues.

**T**oday, more and more mental health professionals seek education and enlightenment regarding these issues. There are also increasing numbers of gay & lesbian (and gay-friendly or gay-aware) therapeutic professionals. The conferences that I attend for work often feature seminars on treatment affecting the gay & lesbian community.

But we still have a long way to go.

In the University of Washington survey, forty-six percent of gays & lesbians who sought mental health services reported encountering a homophobic therapist; thirty-four percent reported that their therapists had refused to acknowledge their sexual orientation, or had dismissed their homosexuality as a temporary condition. Many more reported derogatory comments and inappropriate sexual behavior.

As out gays & lesbians, we must help to educate the mental health community and improve services. If you have experienced inappropriate behavior or comments from a licensed mental health professional, report it to the state licensing authority. At the very least, get another therapist.

And let your insurance representatives know that you want to see gay and gay-friendly therapists on company plans.

We have mental health issues like everyone else. Our sexual orientation is not a mental illness or defect. We should demand respect from those we pay to help us.

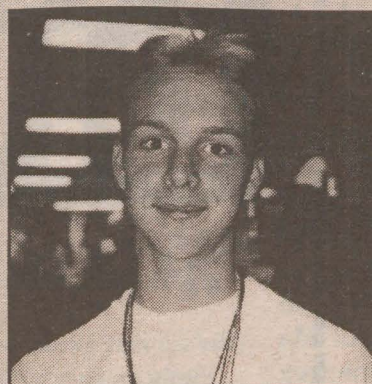

# Making Mary: young fiddler hits town

It's a long way from the frigid streets of Creignish — a village on the island of Cape Breton, off the coast of Nova Scotia — to sunny Tempe. Queer Canadian fiddler Ashley MacIssac, a native of that tiny, Celtic satellite community somewhat east of here, will be making the trip on Friday, February 28 as part of his current tour.

The tour is to promote the U.S. release of MacIssac's debut album, *HI, How are you today?* The album has made the Top 10 on Soundscan's Alternative New Artist chart. The first single, *Sleepy Maggie*, is getting heavy airplay in markets across the country. In Phoenix, the single reached #1 in phone response at KZON, an alternative rock station, in late January.

Now 21, MacIssac has been playing the fiddle since the age of 9. He has become a legend in his hometown, and throughout eastern Canada. MacIssac grew up in a village that has been called a, "transplanted Scottish highland," where the fiddle and bagpipes are the only instruments anyone really plays. He never even watched television until about three years ago, and has used the influence of TV in recording the songs for his album.

The good-looking, young fiddler created a minor sensation while appearing on *Late Night with Conan O'Brien* in January. During the taping the fiddler kicked, his trademark kilt flew up and the age-old question, "what do Scots wear under those things?" was answered in an instant, amid gasps from the studio audience.

NBC censors, however, were able to act in time to keep all of MacIssac's "secrets" covered for home viewers.

MacIssac has been open and candid about his homosexuality, after he was outed by the Canadian magazine *Frank* last year. On tour with his band, the Kitchen Devils, MacIssac garners rave reviews for his high-volume, high-energy shows. His stage presence and act are hard to define, as the Highlander meets the Grungeboy and integrates it into one, cohesive package. Dripping sweat and working himself into a fiddling frenzy, he can go through a bow every five minutes.

The music sets are as eclectic and dramatic as the recorded album, according to his publicist at A&M records. "If you liked his album," she promises, "you're going to love Ashley MacIssac live." The debut album fuses a strikingly original blend of industrial/grunge, traditional Scottish music, and soothing, alternative ballads. The vocal and musical arrangements feature a number of guest artists, including the eerie, Gaelic crooning of Mary Jane Lamond on the hit, *Sleepy Maggie*.

MacIssac promises even more variety for his next studio effort, including the possibility of a hip hop track, a Ramones-sounding fiddle track, and at least one high energy dance track, for which he hopes to be paired with disco diva RuPaul.

Catch his act, with the Kitchen Devils and Tara MacLean, on February 28 at Gibson's, 410 S. Mill in Tempe. The 21 and over show starts at 7pm.

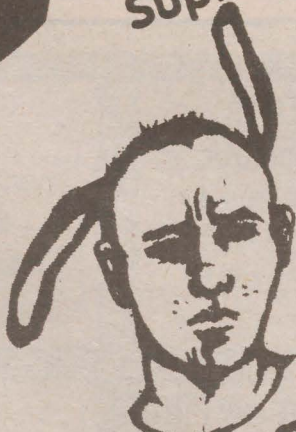

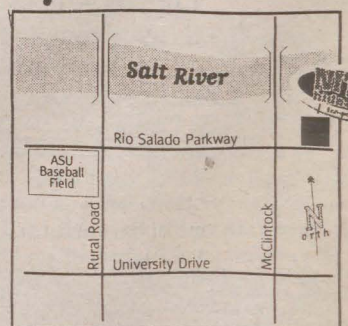

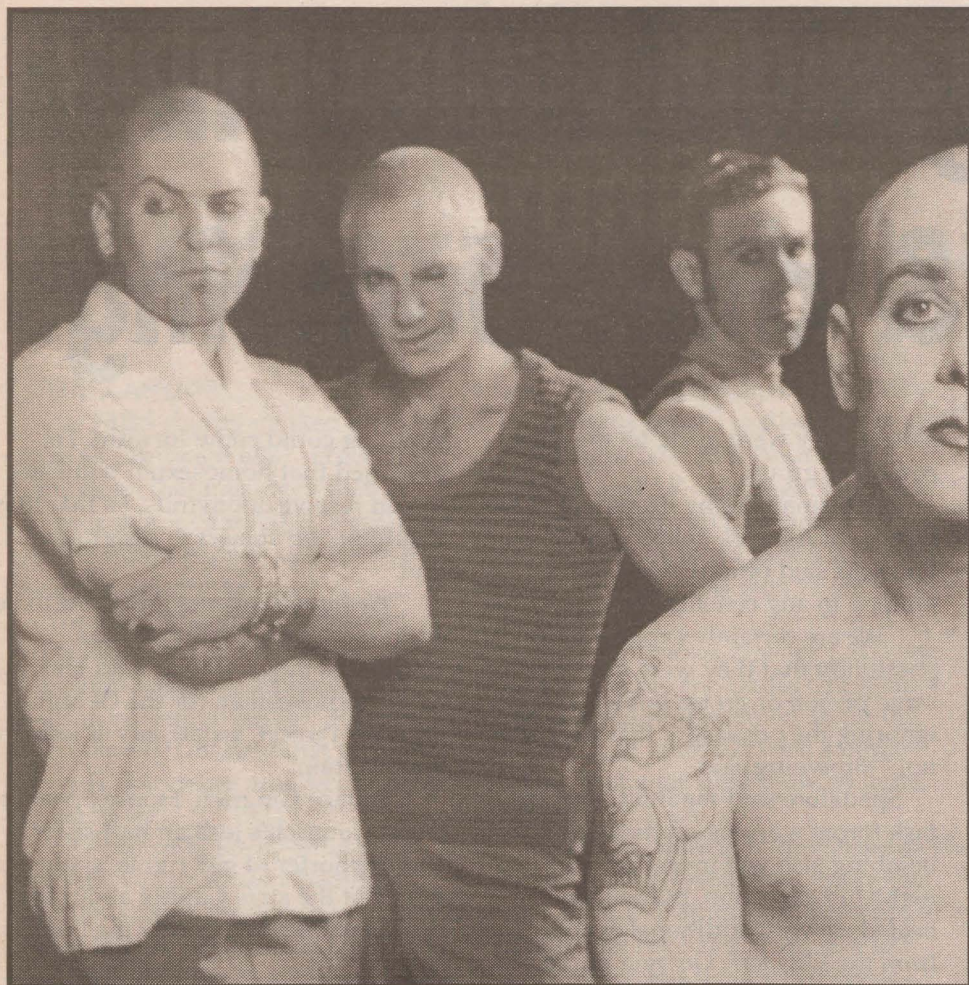

really getting into what is almost a hip-hop groove. I don't know if they'll all be on the album, but we'll definitely have something representing that feeling. I love it.

**HS:** *Sinnerman* covered quite a spectrum.

BG: The next album will be even more diverse. I'm listening to a lot of different stuff, including rhythm and blues. My head is always changing, my attitude toward the stuff going on around me and the shit we went through last year (getting dropped by Atlantic only eight weeks after *Sinnerman* was released). For example, I have gone back to work, cleaning houses. I had to. You'd think that would bring me down, but that's part of what I have to do.

**HS:** *But, just one year ago, you were on the verge of the big time...*

BG: I know now that it (record-sales success with Atlantic) was not meant to be. I see how things happened the way they did for a reason. I am getting it together in a lot of ways, and that includes spiritually. That sounds hokey, but it's true. We are going to make this band work because we all care about the music and because it is one helluva band.

**HS:** *You sound practically giddy.*

BG: What really picks me up is doing our live shows, and working on this new stuff. I am happy and excited right now, and that changes things. I could never write another *Violator* again.

**HS:** *Violator is very angry song — are you saying you've gone soft?*

BG: I still have an angry side, and I'll always write from that part of me. But I'm in a different place now, I have a much more positive outlook. I am definitely more mature. The music I write changes accordingly. It has to, in order to be honest. Which is not to say, we don't still rock!

**HS:** *Who comes to your shows?*

BG: In LA? All kinds. Hard-core rockers, punks and gay leathermen... kids who want to slam... gay men who normally would listen to older rock and roll... we reach out to a lot of different people. If there's anything good about my being known for being gay, that's it. It expands our audience.

**HS:** *And when you play out of town?*

BG: That depends. Usually, it's more of a college crowd or alternative-type audience. Which is great, too. We'll rock wherever we are, whoever shows up.

**HS:** *What strikes me about your Atlantic album, *Sinnerman*, is the technical proficiency. It has these subversive elements, and the punk/garage-rock sound is there. But it seems very skilled at the same time.*

BG: Thanks. We are very proud of our musicianship. It's just the way we work. We have been in this for awhile and work together very well at this point. I know that if we stick to what we are good at and just keep doing it right — not worry about where it is going to end up, but just do it to please ourselves — we can put out the sound we want and continue to get even better.

**HS:** *Will Extra Fancy ever do a dance song for the gay clubs?*

BG: It would be hard for me, because people hear that I'm gay, they see our name, and then they assume that's the kind of music we probably do. It isn't as if I don't like techno and dance music. We have talked about doing remixes of some of our stuff, but it has to be done right and I haven't got the vibe yet for how we're going to pull it off.

**HS:** *You've been doing this awhile, while other bands have come along*

*and become more commercially successful.*

BG: Yeah. Take the Garbage album. It isn't terrible, but it drives me crazy. They're trying to jump on something that other bands are doing a lot better, and have been into for a lot longer. You can see the dollar signs in their eyes. And the new song from U2. My friends are like, "this is so cool" — well, I hate it. You can see exactly how their A&R people approached it, thinking, "this is something that is hot right now and here is how we are going to get in on it."

**HS:** *You wrote all the lyrics and a good portion of the music for *Sinnerman*. Now you're sharing more of the duties with the other boys?*

BG: Right. This is what's pulling us closer, after the problems we went through last year. And it's fantastic. I still write the lyrics, but in the past, I would bring in most of the musical ideas myself, in order to get the sound I wanted.

**HS:** *You're telling me you're basically a Control Queen?*

BG: Yeah, kinda. But I don't apologize for it. I'm good at it and I know what I want. I've been in music a long time, and I've learned that a long democracy in a band can never work. In our case, we've been together long enough and know each other so well, that a collaboration is working.

**HS:** *You're 35. When you were a teenager, did you think you'd be doing this now?*

BG: No way — there's no fucking way that I thought I would still be in rock & roll at this age. I thought maybe I'd end up a writer or a painter. Honestly, I expected I would be dead.

**HS:** *C'mon. You're very much alive, and you don't look your age at all.*

BG: Seriously. I never pictured myself at this age, so I really never had any plans for anything beyond 30. It always sounded so old.

**HS:** *What kind of man attracts you?*

I have no type, I like everybody.

**HS:** *Bullshit*

BG: It's true! I am into personality — guys who have a lot of self-confidence, who aren't looking to attach themselves to me, just because I'm "Brian Grillo." A nice smile is extremely important. Physically, it doesn't really matter. Not a bit. I'm not turned on by what most gay guys think of as hot. You know how queers usually are: they think a hot

man can only be good looking, with a big, hard, gym body — that kind of thing. But I never cared about that.

**HS:** *Sure, whatever. I believe you. So, are you seeing anybody now?*

BG: Actually, I have been dating someone for about four months and it's going very well, because he is totally his own person, with a very secure life, a good job, his own set of friends. And he never hangs on, following after the band, because he has no need to. That is what turns me on.

**HS:** *What's he look like?*

BG: Actually, (starts laughing) he's a very good looking guy, with a big, hard, gym body- (really laughing, now) guess I never realized that.

**HS:** *You've been on several magazine covers, including POZ. Where did your poster boy image come from?*

BG: Everyone else made a big deal of my being a queer, rock musician. Not me, and not this band. We worked that issue out a long time ago. It was the record company and the press that did it. It pisses me off — the idea that testing positive is some sort of gimmick? That is so fucking insulting. We made many mistakes, letting [Atlantic Records] set us up as the next, big, gay thing the way they did. I never asked to be a queer role model. I'm a rock musician. They are going to have to get a new, HIV+, queer poster boy for 1997. I am not doing it any more.

**HS:** *You'd rather be portrayed as a role model for aspiring oil drum players?*

BG: Exactly! That would be great.

**HS:** *Then shouldn't you have kept your mouth shut about your sexuality from the beginning?*

BG: The beginning was so long ago for me. When we first started, it (staying closeted) was not a choice for me. I don't see how other queer musicians can pretend they aren't gay. Then, there's this thing where they figure they'll wait until they "make it big" to come out. That's really insulting, especially when you're talking about someone who's already fucked half the men in Hollywood.

**HS:** *And you have?*

BG: Let's just say... I've been kicking around this town a long time.

# Agents examining similarities in lesbian nightclub & clinic bombings

ATLANTA (AP)

Two federal agencies are investigating possible links between Friday night's bombing at a gay & lesbian nightclub, and one at a suburban abortion clinic last month.

"There are some distinct similarities between the devices," FBI spokesman Jay Spadafore said Sunday. "But there are still some distinct differences, which makes it impossible to conclude that the bombings were committed by the same individual, or individuals."

"We have the possibility of a serial bomber; we also have the possibility of a copycat," Atlanta Police Chief Beverly Harvard said today on ABC's "Good Morning America."

"Nothing at this point has been excluded," she said.

Two bombs were left at the abortion clinic and two at the nightclub, one of which police detonated Friday night using a remote-controlled robot.

Both bombings used large nails as shrapnel. Officials say the bombing seven months ago at Centennial Olympic Park appears to have more differences than similarities with the other two.

Federal agents were back at the nightclub today, combing the area for the tiniest bits of evidence.

"Two weeks from now, we might have a much better idea if these bombs are made by the same person," Spadafore said. "More clues are left behind each time a device is discovered or detonated. We now have five separate devices."

Mayor Bill Campbell was asked today whether last week's sentencing of three Georgia militia members on pipe-bomb conspiracy charges could be related to the latest bombing.

"There is no doubt that that raises questions in the minds of the law enforcement officials that are investigating," he said on NBC's "Today" show. But he added, "It's impossible to determine at this time."

ABC News reported Sunday that investigators had linked the January bombing at the Atlanta Northside Family Planning Services clinic with the attack at The Otherside Lounge Friday night, which injured five people.

The network said a number of components in the bombs — specifically the wiring, timing and dynamite — were so similar that officials

believe they were made by the same person or group.

Spokesman Bobby Browning of the Bureau of Alcohol, Tobacco and Firearms said officials have not jumped to any conclusions.

"We are certainly exploring the possibility that they were made by the same person or group but we are not ignoring the possibility that they were not," Browning said.

Spadafore said the multi-agency task forces working on the clinic bombing also will investigate the nightclub explosion, but will be beefed up with additional agents from the FBI, ATF, Georgia Bureau of Investigation and local police.

The Olympic Park investigation will remain separate. Campbell said today that Atlantans aren't living in fear of a serial bomber. "The people in Atlanta are moving forward," he said. "There is no sense of panic here. People are very calm."

Earlier, the mayor called the nightclub bombing a hate crime and ordered extra police protection for other such nightclubs in the city.

"Anyone who plants an explosive device that targets a particular group is expressing hatred," Campbell said. "Gays and lesbians were targeted in the first bomb. Law enforcement officials were targeted with the second one."

Campbell met with gay & lesbian activists Sunday to discuss how potential witnesses to the nightclub

bombing could come forward. He promised that homosexual witnesses would receive anonymity, so that they would not be subject to discrimination.


"We have concerns that need to be addressed, and (Campbell) has assured us they will be," said Harry Knox, a spokesman for the Georgia Equality Project, a state gay & lesbian organization.

Candace Gingrich, House Speaker Newt Gingrich's lesbian half-sister and supporter of gay rights, spoke at a rally at the state Capitol about the lack of public outcry over the bombing.

"If you recall when the (clinic) bombing happened in Sandy Springs, within minutes ... the president and my brother were denouncing what happened," she said. "Considering this is the speaker's adoptive home state, it's rather — I think — embarrassing that we have not heard a word from his office."

Later, Gingrich issued a statement condemning the bombings as "inexcusable acts of terrorism that should outrage all Americans and cannot be tolerated."

Rep. John Lewis, D-Ga., called on Attorney General Janet Reno to have the Justice Department investigate the latest bombing as a hate crime.

## Seattle schools accept grants to buy gay & lesbian family books

SEATTLE (AP)

On the cover of *Daddy's Wedding* by Michael Willhoite are pictures showing a wedding cake, a man with his arm around another man, and the two men giving each other pieces of cake.

That's one of the books being provided to public grade school libraries throughout the city, under a \$6,150 grant from the Fund for Lesbian & Gay Families with Children, endowed last year by City Council member Tina Podlowdowski and her partner, Rochelle Mileur.

The books are part of a project designed to increase understanding of different kinds of families and "dispel myths and stereotypes," according to the school system's grant application.

The project amounts to promoting homosexuality, said state Sen. Harold Hochstatter, R-Moses Lake, who supports a bill to bar discussion of homosexuality as a normal or acceptable lifestyle in the public schools.

"It is very, very subtle," Hochstatter said Friday. "The subtlety is the poison in this whole thing. It is the kind of thing these children would be vulnerable to, and needs to be resisted."

Tracy Flynn, a school system health curriculum specialist, denied that the schools were promoting any lifestyle. "We are just acknowledging what already exists," Flynn said. "Our goal is to support all families. Gay and lesbian families exist in our district."



# AMFAR pulls national ad campaign after Texas complaint

DALLAS (AP)

An AIDS charity yanked a nationwide ad campaign after receiving complaints that messages such as "Prayer won't cure AIDS. Research will" insulted people who believe in the power of prayer.

The American Foundation for AIDS Research said objections to the campaign focused on two of three ads that ran on public buses: "Prayer won't cure AIDS. Research will" and "Sexual abstinence won't cure AIDS. Research will."

City transit agencies in both Dallas and Fort Worth already had heard objections and canceled the bus ads earlier this month.

"AmFAR seeks to educate, not offend the public," said Dr. Mathilde Krim, chairwoman of the board of directors of New York-based AmFAR, a pet charity of actress Elizabeth Taylor.

"Since the complaints over two of the ads distract from our crucial mes-

sage — that only medical research can generate true solutions to AIDS — we have agreed to discontinue the campaign," she said Wednesday.

The AmFAR campaign, launched Feb. 1, was due to run through the spring. The other ad in the campaign read: "Red ribbons won't cure AIDS. Research will."

KCBI-FM news director L.B. Lyon said a caller to the Dallas Christian radio station complained about the ads, and he followed with a news story. That generated more protests, he said.

Christian leaders in the Dallas-Fort Worth area stressed Wednesday that they didn't disapprove of research to find a cure for AIDS. They just felt that prayer and sexual abstinence shouldn't be slighted.

"That's just a swipe in the face of praying people," said David Miller, executive director of the Tarrant County chapter of the American Family Association. "It's almost as if ... they were trying to offend people.

It's certainly catching people's attention. And anybody that believes in prayer is going to be offended."

The vast majority of AIDS victims are infected because of "immoral or illegal behavior," Miller said.

"Research is not going to stop the AIDS epidemic. It's changes in behavior," he said. "That's the ad that needs to go on the side of a bus."

Misleading children into believing that abstinence or prayer won't make a difference is "irresponsible," added John J. Dwyer, editor and co-publisher of The Dallas/Fort Worth Heritage, a monthly Christian newspaper.

The in-house marketers for Kenneth Cole Productions, a shoe manufacturer, created the ad campaign. Kenneth Cole is director and chairman of the communications and marketing committee of AmFAR.

Cole, who said the first complaints were from Texans, said the ads were not meant to demean prayer, but to battle indifference to the deadly disease. He hoped the controversy

would have the residual effect of promoting the message, even though the ads are gone.

"Right now people have become dangerously complacent," he said. "We've basically all become so desensitized over time. We need to startle people, to grab their attention."

Thomas Bruner, executive director of Tarrant County's AIDS Outreach Center, said North Texas is known to be conservative, particularly when sexuality and religion are involved.

But he didn't object to pulling the ads if they offended. He just doesn't want the research message to be obscured.

"There is no substitute for this country's political will to fund basic biomedical research to find a cure for AIDS," Bruner said. "Not laughter, not hope, not compassion, not prayer, not anything."

# SF business group wants benefits limited to gay partners only

SAN FRANCISCO (AP)

Straight, unmarried couples should be excluded from San Francisco's domestic partners law because they can legally marry, a business lobbying group said.

The city has passed an ordinance requiring companies with municipal contracts to provide benefits to domestic partners, and affected companies are seeking to soften the financial blow.

Meeting with Mayor Willie Brown and three members of the Board of Supervisors, Committee on Jobs representative Doug Shorestein proposed Thursday that companies be required to provide benefits only to gay couples if married workers receive them.

Mark Mosher, executive director of the Committee on Jobs, said paying for benefits is an expensive proposition for businesses and noted that opposite-sex domestic partners can legally marry, unlike gays, and get benefits that way.

"It's a big difference," Mosher said. "Some of (the reason for the proposal) is definitely money, and some of it is the principle."

The domestic partners ordinance, which takes effect June 1, requires companies and organizations doing business with the city to provide the same benefits to workers with registered domestic partners as they do to married employees.

The law has upset companies including United Airlines, which had a 25-year lease at San Francisco

International Airport held up while supervisors exacted a promise that the company would at least show a good-faith effort to implement domestic partners benefits within two years.

During negotiations, United said providing benefits meant changing policies for 80,000 workers nationwide, not just in San Francisco.

Business leaders at Thursday's meeting also said the ordinance could be amended to allow workers in cities without official domestic partners registries to sign an in-house affidavit with the companies confirming their partnerships. That way, they could receive benefits.

Brown hasn't formed an opinion on either proposal, said spokeswoman Kandace Bender, but is hopeful a compromise can be reached.

"The mayor's office and the Board of Supervisors are in consultation on both of the issues," Bender said. "We all understand it takes some time to

reorganize the way the companies do business. We believe a compromise will be reached."

No agreements were reached during the closed-door meeting. But Supervisor Tom Ammiano, who was there, said the city ordinance was intended to benefit straight, unmarried couples as well as gays and should not be watered down.

"It's not a second-class marriage; it's an alternative marriage," Ammiano said.

He added, however, that he could probably live with a provision that would allow companies that offer benefits only to married and gay couples an extension to comply fully in offering the same benefits to partners of straight workers.

As for the affidavit plan, Ammiano wouldn't rule it out but said he wanted to make sure it wouldn't dilute the legitimacy of domestic partners registries.

# APAZ to open Wellness Center

Being Alive, the early intervention program of AIDS Project Arizona, will be opening a program satellite facility in mid-March at 1840 West Maryland Avenue, Suite C. The new offices will be part of what will now be called the Being Alive Wellness Center.

Dr. Steve Karpiak, Ph.D., is the director of Being Alive. "We are very excited to be able to offer this, and we owe a debt of gratitude to Community Hospital," Karpiak says. "They have very generously leased this suite of offices, including furniture and utilities, to Being Alive for only \$1 per year."

The primary new program at the Wellness Center will be the Being Alive Clinic, sponsored by Dr. Ian Bier of the Southwest College of Naturopathic Medicine and Health Services. Dr. Bier was a member of the Immune Clinic at Bastyr University in Seattle. "Dr. Bier and his staff will provide nutritional, chiropractic, massage and acupuncture therapies for Being Alive," says Karpiak. Initial, qualifying participants will not be charged for these services. As the program grows, a sliding scale of fees will be developed.

Karpiak says the mission of the new Clinic is to treat HIV positive and AIDS patients with preventative and natural medicine, in order to improve the patient's quality of life and to empower the patient as a

partner in his or her own health care. He explains that the expansion of the program is the result of APAZ's effort to provide additional support to people infected with HIV who are already using Being Alive's services, and to increase enrollment in the program.

In addition to Dr. Bier and his staff, other chiropractors and massage therapists will offer their services for free at the Wellness Center. The Being Alive Buyer's Club will set up a satellite facility at the Wellness Center as well, expanding its inventory of products to include items required by naturopathic physicians.

Being Alive has also added a new, part-time health care professional to its program. Counselor Brady Dalton, CMSW, will be based at the new Wellness Center. Mr. Dalton will be taking appointments for individual, group-focused and peer group-facilitated counseling sessions.

Karpiak says that people interested in learning more about the role of naturopathic medicine in the management of HIV/AIDS would do well to attend the free, Positive Living for Us (PLUS) weekend (see their ad, this page), on March 15 and 16 in Tempe. "There will be seminars given by naturopathic physicians, and all PLUS attendees will be able to get free acupuncture, chiropractic and massage therapies."

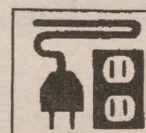

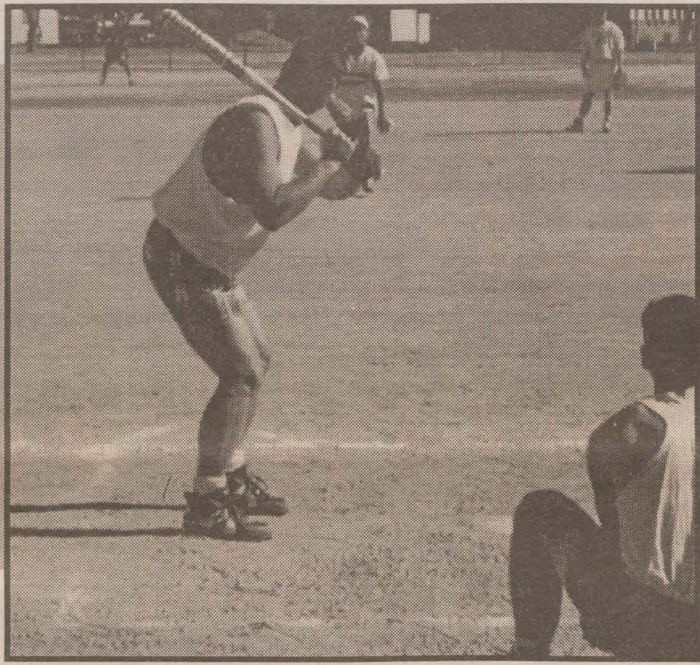

## DA plans camp out at Userly Mountain

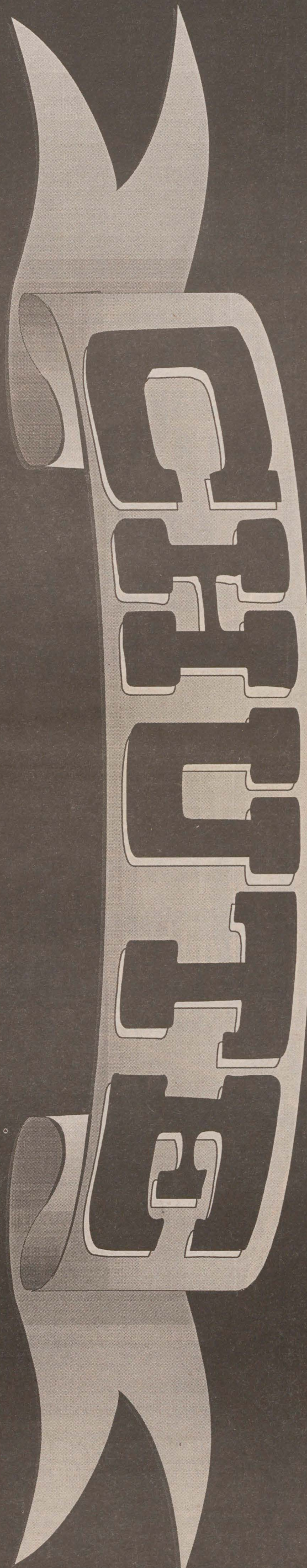

This collaboration led to a new record deal, Tina's 1982 comeback cover of Al Green's *Let's Stay Together*, and, in 1984, *Private Dancer* — an album that sold 11 million copies.

## Did he, didn't he, or... is it he?

To call *Lost Highway*, the new film from David Lynch, a roller coaster ride would not only be cliché, but inaccurate. One can at least see the end of a roller coaster coming, and the adrenaline rush is fairly constant, after topping the first hill.

There is probably no one currently working in Hollywood who presents camp better than David Lynch. And *Lost Highway* — Lynch's first wide-release feature flick in over 4 years — may be his finest camp effort yet. Despite it flashes of brilliance and incredible style, the film is also deeply, even ingeniously, flawed.

Functioning as the ultimate haute-tour, Lynch has thrown the message out the window. He's handed us tons of form, with absolutely no function. The convoluted, eerily beautiful result is both fascinating and infuriating by turns.

Best known as the creator of *Eraserhead*, *Twin Peaks*, and *Blue Velvet*, Lynch also directed *Dune*, *The Elephant Man*, and *Wild at Heart*. By shucking conventional narrative, the director (with co-writer Barry Gifford) presents a quirky, dreamlike film that is as frightening and dark as it is visually stunning.

*Lost Highway* takes place in an odd, Los Angeles-like city where the past, present and future seem to exist simultaneously. Jazz Musician Fred Madison (Bill Pullman) lives in big, white house on a quiet street with his laconic, auburn-haired wife Renee (Patricia Arquette). He finds himself being terrorized at parties by a creepy, pimp-like guy (Robert Blake) and also by an anonymous weirdo with a video camera.

It seems someone is taping Fred and Renee's boudoir from inside the house, then dropping off tapes of the couple, asleep at night, on their own doorstep every morning. Renee gets a bad case of the yuckies and calls the cops; Fred just gets pissed.

He gets even more pissed when he realizes Renee may (or may not) have been hideously murdered and that he may (or may not) have killed her, himself. The fact that he's talking to her in the next room apparently has no influence — remember, this is Lynchland. Renee is definitely dead and chopped up into little pieces somewhere. And yet, she is alive and well. *Maybe*.

Hang on, it gets even weirder and juicier than that. Fred is arrested and

sentenced for the murder, then placed into solitary confinement, where he promptly gets a severe headache. But instead of turning to aspirin, Fed turns into an entirely new person and *Lost Highway* turns into a new movie. As youthful auto-mechanic Pete Dayton (Balthazar Getty), our lead character is released by his perplexed guards and returned home to his job and family, unable to remember where he's been or what he's done.

Patricia Arquette shows up again, only now she's a vivacious, blonde bombshell named Alice Wakefield. This spirited, hooker-turned-gun expert has only to waggle her perkies in Pete's adorable face before the lad is completely smitten (it's always amazing to learn what a well-fitting, push-up bra on a gorgeous actress can accomplish in comic-book, hetero-sexist movie worlds like the ones Lynch creates. Indeed, put a nice booty in a satin skirt, and the entire plot changes), no dialogue required.

A little macho lasciviousness is more than acceptable, however, because the movie becomes a lot of fun at this point. The young lovers have plenty of steamy sex while planning to escape the clutches of the wealthy gangster Mr. Eddy (Robert Loggia), who is Pete's mentor and (of course) Alice's main squeeze. The film races toward a climax that we never see coming because we're still trying to figure out where we've been.

It is Patricia Arquette, in her dual role, that pulls Lynch's obscure vision together. The talented actress manages to give us dumb/smart, sexy/naive and lazy/driven at the same time. Both her characterizations in *Lost Highway* owe as much to Russ Meyer's crazed vixens as they do to classic, film noir babes-with-brains from the likes of Douglas Sirk. Arquette always brings something special to her work, and Lynch was able to tap into it.

Gary Busey does a great turn as Pete's befuddled father, and Michael Masee is very effective as a sleazoid porno producer — one of a scant few characters who turns up in both of the film's semi-separate worlds. The soundtrack is exceptional; the sound design, also credited to Lynch, is superb.

Much has been made of the influence of television on Lynch's feature films. In *Lost Highway*, that influence is present and palpable. The lighting, color and costuming create a kind of 1970's, television-movie mood. Every nuance is covered. The actors even deliver much of their dialogue in a formulaic cadence that appears borrowed from predictable, stale police dramas like *Streets of San Francisco*, or even those with the cheezy intensity of *Charlie's Angels*.

It would be easy for someone with Lynch's abilities to poke fun at his inspirations, and he tries to do so. There is a difference, however,

between camp and parody. Part of Lynch's makeup is that he pretends to be about humor, while taking himself so seriously that no one else gets the joke. Camp, style, wry humor, those he can do. But parody? Nope. He is paying homage here, something that is very hard to do effectively (especially in 135 minutes) without boring the viewer. And therein lies *Lost Highway's* flaw.

If the roller coaster is considered the ultimate ride, it should be duly noted that — though it comes close — *Lost Highway* is no roller coaster. It's exciting and well-crafted. But it's spasmodic. Like eating a double serving of fry bread and then riding the Zipper, the Top Spin, or even the giant Ferris wheel, it's the pauses that get to you. And you find yourself wondering just when this damned ride is going to end.

## No love lost for gay people on MTV's *Loveline*

On *Loveline*, MTV's late-night call-in sexual advice program for young people, a disturbing trend has developed involving both co-hosts Dr. Drew and Adam Carolla that is creating an atmosphere of alienation for lesbian, gay and bisexual youth.

On the December 27 program, Dr. Drew referred to anal sex as "not a very loving act," and said that it was not worth the health risks.

On an early January show, a caller said that he'd performed fellatio on fraternity brothers as part of hazing, that he liked it, and that he was beginning to think about sex with men.

Dr. Drew said he might be gay but hadn't dealt with it, but essentially ignored any discussion of bisexuality.

On January 17, a young man called with concerns that he was having sexual fantasies about men. Dr. Drew told him that either he had suffered some sort of trauma, perhaps in childhood, or that he was gay and needed to deal with it. A guest host suggested that the man could be bisexual, which Dr. Drew shot down, saying essentially that bisexuality is very rare and that most people who call themselves bisexual are suffering from "sexual ambivalence" and need to deal with what "caused" that.

On February 6, a student called about being pressured to join his father's fraternity, which, at his college, was now a gay frat. Carolla said, "Lord knows what goes on in their hazing!" The laughter continued, and by the time Dr. Drew suggested that "there's nothing wrong with being gay, you're just not into that," everyone had already spent a great deal of time smirking about gay sex, straight discomfort with gay sex, and the idea of a straight person rushing a "gay" fraternity.

It was akin to making fun of African-Americans for five minutes and then, at the end, saying, "Of course, there's nothing wrong with being black..."

While MTV has almost always been an industry leader in its representation of lesbian, gay, bisexual and transgender people, *Loveline* needs to review some very basic realities about being sensitive to gay and bisexual sexuality.

The information Dr. Drew, the supposed voice of authority, espouses about both anal sex and bisexuality is flatly inaccurate, and the general atmosphere of mocking and giggling about lesbian, gay and bisexual orientation is the *Loveline* norm.

When approached by GLAAD, both representatives from MTV and *Loveline* Producer David Sittenfeld, who is openly gay, expressed a desire to address the issues GLAAD cited and a willingness to have an open dialogue about issues with the show.

Please write to MTV and *Loveline* and let them know that for a show that professes an openness and knowledge about sexual matters, *Loveline* can sometimes be insensitive and ignorant. Also, if you hear something you disagree with, call them on air about it.

## TV Guide Says Citizen Ruth may be Ellen's girl

On February 20, *TV Guide* leaked inside information about the *Ellen* show, indicating that on the proposed hour-long April 30 coming out episode, Ellen's love interest (yes, she will have one) will be played by Laura Dern (*Citizen Ruth*), and, as GLAAD previously reported, Oprah Winfrey will be playing Ellen's therapist.

ABC and Touchstone Television, however, still refuse to saying any more than that ABC Entertainment President Jamie Tarses still has not seen or approved the actual script.

In the February 22 *TV Guide*, "The Couch Critic," Jeff Jarvis, expressed his own exasperation over ABC's foot-dragging about letting *Ellen* out of the closet. "Ellen DeGeneres' game of sexual-preference cat and mouse has gone on too long," he writes.

"So why doesn't she just open the closet door, already? She is treating lesbianism as a shameful tittle, a dirty secret. I thought we were past that by now." He criticizes the show, but has faith that it will be stronger for the decision to come out: "The show and the star should both just decide what they are, announce it, and be proud of it. Enough rambling."

ABC's attempt to continue hyping the "will she or won't she?" has many viewers, GLAAD and the media frustrated and puzzled. With sponsors willing to endorse an out *Ellen* and fans of the show eager to see the development of the character, it is beyond comprehension why ABC Entertainment President Jamie Tarses does not give her endorsement to a coming out story line that is clearly already well into development and set to air April 30.

Write ABC and tell them it is time that Tarses review the script and get on with the show. Also, please thank *TV Guide* for keeping pressure on ABC.

On a show that has always been overwhelmingly positive and admirably inclusive of lesbians and gay men, "Homer's Phobia" stands out as a shining example of how to bring intelligent, fair and funny representations of our community onto television.

Even closeted Smithers has a brief appearance as a jealous friend of Waters who, upon discovering him hanging out with the Simpsons, says, "So THIS is the sick friend you're visiting?" Such little touches make *The Simpsons* one of the best and most gay-positive shows around.

## Four boys kissing

Two recent sitcom episodes featured reluctant male same-sex kisses.

On the January 23 episode of NBC's sitcom *The Naked Truth*, two straight men posed as gay and engaged in lip-locking.

Two regular characters, Nick (Jonathan Penner) and Dave (Mark Roberts), are "outed" as gay to their boss, Les (George Wendt) by a co-worker. Les tells the two that he wants them to sit with his father at the Superbowl to educate him about gay men.

To get the tickets, Nick and Dave play along, acting affectionate, but a co-worker almost blows their cover.

Les says they have to prove they are gay by kissing. They do after a little protesting, and to Nick's surprise, Dave won't let go. When Nick reacts to Dave's passions, Dave responds, "You loved it and you know it."

On ABC's *Spin City*'s February 11 episode, Carter's (Michael Boatman) dreams of reconciliation with an ex-boyfriend (Luke Perry) are dashed when Perry tells Carter he has "decided he is straight" and is getting married to a woman.

In response, Carter drags Mike (Michael J. Fox) into a charade in which the two of them act as if they are a couple, and includes a kiss between them. Mike acts shocked by the kiss and goes over the top in his discomfort, but in the end lets Carter know that he'll always be there for him.

The shows represents network television's progress towards networks allowing gay male same-sex kissing.

While lesbian couples have recently broken through the barrier, in made-for-TV movies such as *Serving in Silence: The Margaret Cammermeyer Story* and *Two Mothers for Zachary* and on ABC's drama *Relativity*, gay men, such as Matt on *Melrose Place*, still settle for hugs.

First it was two straight men, then a straight man and a gay man who are pretending to be partners-maybe next time it can be two gay or bisexual men who really mean it. The presentation of male same-sex kissing is critical to our community's realistic representation, and destigmatizes portrayals of our love.

Write NBC and ABC and let them know that this sexual charades and sexual orientation play is appreciated, and encourage them to expand portrayals of same-sex kisses to characters expressing true love and affection.

# Zimbabwe judge rules ex-president forced police aid into gay sex

HARARE, Zimbabwe (AP)

In a country known for gay-bashing, sensational trial testimony revealed Monday that former President Canaan Banana forced an underling into 3 years of homosexual acts.

The graphic, emotional testimony from a policeman charged with murder was certain to shock Zimbabweans used to anti-gay rhetoric and threats of a crackdown on homosexuality from President Robert Mugabe, a close political ally of Banana.

Policeman Jefta Dube, 36, said he shot dead a colleague who teased him about his three-year homosexual liaison with Banana, 60, a Methodist preacher, theologian and African peacemaker.

Judge David Bartlett sentenced Dube to 10 years in prison for murder, but said the evidence of Banana's sexual abuse was a mitigating factor that reduced the penalty.

Prosecutors had asked for life imprisonment, though the maximum penalty for murder is death.

The case was the first official disclosure of Banana's long-rumored homosexuality, and came after Mugabe led an outspoken campaign against homosexuals, describing them as "lower than dogs and pigs."

Homosexuality is illegal in Zimbabwe. Gay activists have been put under surveillance, but none has been arrested or prosecuted.

In a ruling that took 3 1/2 hours to read Monday, Bartlett said the court must accept evidence including expert psychiatric testimony that Dube suffered from post-traumatic stress, caused by his revulsion to homosexual acts with Banana, when he shot a colleague in the head in September 1995. A news blackout on the trial that began Jan. 27 was lifted with the reading of Bartlett's ruling, which quoted shocking excerpts of Dube's testimony about oral sex, kissing and rape by Banana.

There was no comment available Monday from Banana, Mugabe or official government spokesmen.

Bartlett said he would recommend that Attorney General Patrick Chinamasa and police investigate possible criminal charges against Banana, who is married with four adult children and is the author of four books on theology.

"It is important no one is seen to be above the law," Bartlett said.

Byron Hove, Dube's lawyer, said he would pursue civil damages and criminal charges against Banana, and appeal Dube's conviction and sentence.

"What my former head of state was doing is an embarrassment to me, but it would be more embarrassing if nothing was done about it," Hove said. "If it wasn't true, he was free to come forward and clear his name. . . He was on trial by society, he remains on trial."

Some of the testimony quoted by Bartlett portrayed Banana as a sexual predator, when Dube was assigned as an aide at the presidential residence from 1983 to 1986.

In one incident, according to Bartlett, Dube testified he was given a drugged drink by Banana, who then caressed and kissed him and started removing his trousers.

Dube told the court he awoke later wearing only a shirt to see Banana smile and tell him: "We have helped ourselves."

But because Dube, a married man, was afraid of losing his job, he "unwillingly succumbed to Banana's sexual advances when on weekend duty," Bartlett said.

Dube first reported the sexual abuse to his police superiors; he was eventually transferred to a provincial police detail in the western Midlands province.

Former senior assistant police commissioner John Chademana told the court he was not surprised by

Dube's formal complaint against Banana because "there were numerous intelligence reports of a similar nature."

Banana was Zimbabwe's non-executive president for 7 years after independence from Britain in 1980, while Mugabe was prime minister and effective leader of the country.

He was appointed an "eminent person" by the Organization of African Unity to help negotiate peace in Liberia and Sierra Leone in 1986. In 1989, Banana investigated international business contacts with apartheid South Africa when it faced worldwide economic sanctions.

Mugabe's anti-gay campaign began when the government banned a gay rights exhibit at an international book fair in Harare in 1995. He won widespread support among fellow politicians and ruling party supporters, who assaulted gay rights activists and torched their exhibit a year later — after a court upheld their right to put up the display.

Mugabe earned international censure when he also described homosexuals as perverts who engaged in bestiality, and called on citizens to report them to the police.

is not a celebration of cruelty to animals. If it celebrates anything, it is the tradition of the cowboy's ability to herd and train cattle and other livestock, all in the interest of caring for them. Though methods have changed, the meat and dairy products we eat, the shoes, handbags, belts and clothes we wear are evidence of that tradition.

Second, the animals used in the rodeos have grown accustomed to these activities in their daily lives. Rodeo is what they are bought for, hauled from place to place for, in many cases bred for and, in some cases, delayed from going to the slaughterhouse for.

Third, the International Gay Rodeo Association has very specific rules against real or perceived cruelty to the stock by any contestant. Excessive force, use of electric prods,

and other abuses that were once part of rodeoing are all prohibited by the IGRA. Health certificates are required on all horses admitted to the grounds. Also, some events—calf roping, for example—have been altered by the gay rodeos in order to reduce stress to the animals.



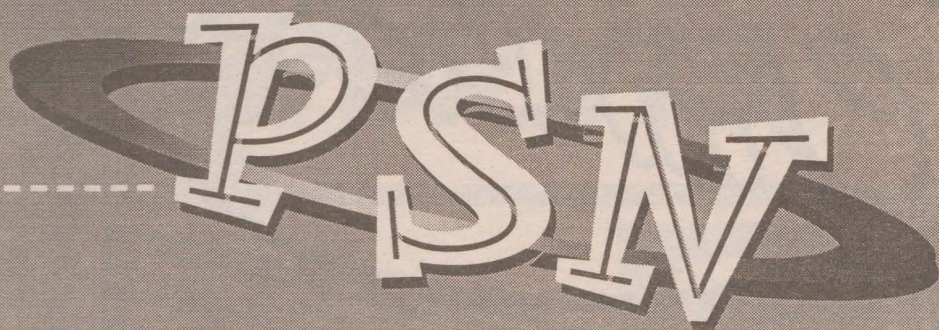
